

ARTICLES OF INCORPORATION AND CONSTITUTION DAKOTA BAPTIST CONVENTION

ARTICLE I - NAME

The name of this corporation is and shall be the Dakota Baptist Convention, Inc.

ARTICLE II - DURATION

The term of this corporation shall be perpetual, unless sooner dissolved.

ARTICLE III - PURPOSE

The purpose of this non-profit corporation, hereafter known as the Convention, shall be to furnish a medium of cooperation for the cooperating Baptist churches of the Dakota Baptist Convention in their divinely commissioned work of missions, evangelism, education, and benevolence. This Convention is an autonomous body made up of messengers in annual session from cooperating Baptist churches to fulfill the purpose for which the churches organized the Convention. This Convention shall not exercise authority over any church. But shall always recognize and uphold the church's autonomy under Christ.

The purposes and powers of the corporation is not intended to prohibit or limit the exercise of any other or further right or power which the corporation might now or hereafter be permitted by law, provided always that such powers shall be exercised for the use and benefit of the membership of the Dakota Baptist Convention and shall be exercised in a fashion consistent with its purpose and fulfilling the Great Commission.

This Convention/corporation is organized, and will always operate, exclusively for religious purposes, and no part of the net earnings of this corporation will ever inure to the benefit or any individual or of any private shareholder, there being no shareholders. Nome of the income of this organization may inure to the benefit of any private individual or member and the assets of the corporation are irrevocably dedicated to and for religious purposes.

ARTICLE IV - MEMBERSHIP

SECTION 1. The members of this Convention shall consist of messengers to the Convention in annual or called session, elected by the Baptist churches cooperating with and contributing to the Convention through the Cooperative Program, and sympathetic with its purposes and work.

SECTION 2. This Convention in session shall be composed of three (3) messengers per cooperating church with resident membership of fifty (50) or less and one (1) additional messenger for each additional fifty (50) resident members or one (1) additional messenger for each \$500 contribution through the Cooperative Program, except that no church may have more than ten (10) messengers. Each church-type mission shall be entitled to one (1) messenger from that mission to the Convention in session and such messenger does not count toward the limit of ten (10) messengers from the Sponsoring Church.

SECTION 3. The basis for determining the resident membership or contributions shall be the previous year's annual report to the Convention.

ARTICLE V - NONPROFIT CORPORATION

This being a non profit corporation organized under Chapter 10-24 of the North Dakota Century Code, as amended, such corporation shall not have capital stock, and no dividends or pecuniary benefits shall be declared or paid to any member thereof. The corporation shall neither have nor exercise any power, nor engage directly or indirectly in any activity that would invalidate its status as an organization exempt from federal income tax and described in Section 501(c)(3) of the Internal Revenue code of 1986, as amended, or the corresponding provision or provisions of any subsequent United States Internal Revenue law or laws (the "Internal Revenue code of 1986"), or that would invalidate its status as a non-profit corporation under North Dakota law.

ARTICLE VI - CORPORATE OFFICE AND AGENT

The address of its registered office is 2020 Lovett Avenue, Bismarck, ND 58504, and the name of its registered agent at such address is the Executive Director-Treasurer of the Dakota Baptist Convention, James Hamilton or his successor.

ARTICLE VII - OFFICERS

- **SECTION 1.** The officers of the Convention shall be a president, vice president, recording secretary, assistant recording secretary, and such other officers as the Convention may deem necessary.
- **SECTION 2.** These officers shall be elected annually by a majority vote of the members present and voting at the annual meeting of the Convention. They shall take office at the close of the annual meeting, and hold office until their successors are elected and installed.
- **SECTION 3.** Other employees of the Convention, its Boards or Agencies shall not be eligible for election to offices. The Executive Director-Treasurer shall serve as the chief executive officer and treasurer of the convention, and serve as an ex-officio with member vote of all Convention and Executive Board committees.

ARTICLE VII - EXECUTIVE BOARD

The Convention shall elect an Executive Board as set forth in the bylaws, and it shall serve as the Convention as interim and as principal advisory to the Convention on its total program.

ARTICLE IX - AGENCIES

- **SECTION 1**. The agency of the Convention is the Dakota Baptist Foundation. The Convention may establish other agencies. All agency board members shall be members of cooperating churches.
- **SECTION 2.** The Convention in annual session shall approve or amend the articles of incorporation of the agency by two-thirds vote, providing no amendment may be considered after the second session of the annual meeting, and that the proposed amendment be submitted in writing to the Convention office at least one-hundred twenty (120) day prior to the annual meeting. Notice of amendments must be published in the state Baptist paper or mailed to the churches at least ninety (90) days prior to the annual meeting.

SECTION 3. The agency board of directors shall be elected by the Convention for a three-year term; one-third elected each year, and shall be nominated by the Nominating Committee. The number of directors, their qualifications and responsibilities, shall be contained in the Agency's articles of incorporation and by-laws. The Nominating Committee's recommendations shall be forwarded to the Convention office on-hundred twenty (120) days prior to the annual meeting.

SECTION 4. If a vacancy occurs, the Executive Board may elect a qualified person to serve until the next regular annual meeting, such person being recommended by the Nominating Committee. In no case may a vacancy continue for longer than six (6) months or until the next annual meeting, whichever occurs first. The Convention shall at its next regular annual session fill the vacancy for the unexpired term.

SECTION 5. Agency board of directors may be replaced by the Convention in session for misfeasance, incapacity, failure to perform their proper duties, conduct which would bring discredit upon the corporation, or transferring membership from a church or mission cooperating with the Convention.

SECTION 6. The Convention shall exercise oversight of all agencies; however, the management of the affairs of each agency shall be by its elected board of directors (trustees). The board of directors shall hold title to properties, real and personal; to act as a fiduciary, fiscal and agent of the agency; to employ agency personnel; to make contracts in behalf of the agency; and to conduct long range planning to reach the objectives of the agency.

SECTION 7. Each agency shall report to the Convention in the Annual Meeting; this report shall include financial audit reports, projected budgets, progress on program objectives in light of long-range plans, and the Convention or its Executive Director may request other necessary information.

ARTICLE X - COMMITTEES

The committees of the Convention shall be a Constitution Committee, Credentials Committee, Resolution Committee, Nominating Committee, and Committee on Committees, Program Committee, and such other committees as are needed to carry out its work. Trustees to Boards and members of committees shall be elected by the Convention, and the plan of organization shall be established in the Articles of Incorporation and Constitution, and the By-laws of the Convention.

ARTICLE XI - MEETINGS

SECTION 1. The Convention shall meet at such a time and place as may be designated by the Convention at its annual meeting.

SECTION 2. In an emergency the president of the Convention, acting in cooperation with the Executive Board, may change the time and/or place of the regular annual meeting.

SECTION 3. In an emergency the president of the Convention, acting in cooperation with the Executive Board, may call a special meeting of the Convention.

ARTICLE XII - CONTRIBUTIONS AND FUNDS

SECTION 1. The Cooperative Program shall be the chief means through which the Convention shall support its missionary endeavors.

SECTION 2. All funds of this Convention shall be raised by voluntary contributions, provided this does not prevent acquiring of property by bequest or use of any bequest or use of any income property that may be bequeathed by the Convention.

SECTION 3. All designated gifts accepted by this Convention shall be used strictly according to the expressed will and direction of the donor.

ARTICLE XIII - INDEMNIFICATION

The Dakota Baptist Convention, and its respective agencies for their work, shall indemnify any trustee or officer or former director or officer of the corporation, and their respective heirs, administrators, successors, and assigns, against any and all expenses, including amounts paid upon judgments, counsel fees, and amounts paid in settlement (before or after suit is commenced), actually and reasonably incurred by such persons in connection with the defense or settlement of any claim, action, suit or proceeding in which they, or any of them, are made parties, or a party, or which may be asserted against them or any of them, by reason of having been trustees or officers or a trustee or officer of the corporation; provided, however, that such indemnity should not be operative with respect to (a) any matter as to which such person shall have been adjudged in such action, suit, or proceeding to be liable for negligence or misconduct in the performance of his duties as such trustee, officer, or employee, or (b) any matter settled or compromised, unless, in the opinion of independent counsel selected by or in a manner determined by the trustees, there is not reasonable ground for such person's being adjudged liable for negligence or misconduct in the performance of his duties as such trustees or officer.

ARTICLE XIV - AMENDMENT

Amendments may be made in this Constitution/Articles by a vote pf two-thirds of the members present when the vote is taken without regard to total enrollment at any annual meeting of the Convention, provided (1) no amendment may be considered after the second session of the Convention and (2) that the proposed change be submitted in writing to the Convention office and the Executive Board at least one-hundred twenty 120 days prior to the annual session and published in the state Baptist paper or mailed to the churches ninety (90) days prior to the annual session.

ARTICLE XV - DISSOLUTION

In the event of the dissolution of the corporation, all of its property, whether real, personal or mixed, of whatsoever nature and wheresoever situated shall vest in the cooperating churches or their legal successors. The corporation shall have authority to liquidate in such manner as they deem advisable and advantageous and turn over and turn over to the North American Mission Board of the Southern Baptist Convention for work in the areas of the Dakota Baptist Convention the proceeds derived from such liquidation.

Assets held by the corporation that are subject to condition requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred or conveyed in accordance with such requirements.

Under no condition or circumstances shall any member or members, director or directors, officer or officers, or any other persons connected with this corporation share in the proceeds of such liquidation.

ARTICLE VI - PROPERTY

The authority under which conveyances or encumbrances of all or any part of the corporate property may be made shall be authorized as established in the Articles of Incorporation and Constitution, By-laws of the Convention.

ARTICLE XVII - INDEBTEDNESS

All borrowing by this Convention for its own use, or for any agencies and institutions, or borrowing by any institution or agency, which directly or indirectly obligates this Convention, the payment of which would require an extension of time beyond the close of the subsequent fiscal year, shall be authorized only on the following terms and conditions.

SECTION 1. the Executive Board shall have authority to borrow funds in anticipation of current revenue, provided that any unpaid balance of such borrowing at the end of the current fiscal year shall be provided in and made a part of the budget for the subsequent year.

SECTION 2. Neither this Convention, nor any institution or agency, owned or supported in whole or in part by this Convention, shall accept or receive, directly or indirectly, any gift, grant, or aid from the Federal or state governments or any government agency, except for definite services rendered by the agency or institution. Such must have the approval of agency's board and reported in full to the Convention's Executive Board.

SECTION 3. No institution or agency of this Convention shall encumber its real property or change its status with respect to this Convention without authority from this Convention.

SECTION 4. Institutions and agencies of this Convention shall have authority to borrow money in anticipation of current revenue, provided that any unpaid balance of such borrowing at the end of the current fiscal year shall be provided for in and made a part of the budget for the subsequent current year.

SECTION 5. Any anticipated borrowing of funds in excess of the provisions of the above sections must have the specific approval of the Convention in session.

ARTICLE XVIII - AUTHORITY-SUPERSEDE

These Articles of Incorporation and Constitution correctly set forth the provisions of the of the Articles of Incorporation of the Dakota Baptist Convention as amended, and they have been adopted as required by law and they supersede the original Articles of Incorporation and all amendments.

BYLAWS DAKOTA BAPTIST CONVENTION

ARTICLE I - MESSENGERS

- SECTION 1. Each church shall present to the Credentials Committee of the Dakota Baptist Convention a list of its elected messengers, according to the Articles of Incorporation and Constitution, Article IV.
- SECTION 2. Each messenger shall register with the Credentials Committee prior to being seated as a messenger to the Dakota Baptist Convention.
- SECTION 3. The Credentials Committee shall review the credentials of the registered messengers and make its report to the Dakota Baptist Convention in the first session of business of the Annual Meeting.

ARTICLE II - MEETINGS

- SECTION 1. The regular meeting of the Dakota Baptist Convention shall be known as the Annual Meeting, and shall be for the purpose of electing officers, receiving reports of officers, committees, and boards, and for any other business that may arise.
- SECTION 2. Robert's Rules of Order, Newly Revised (Latest Edition) shall be recognized as the standard authority to guide the Dakota Baptist Convention on questions of parliamentary law and custom.
- **SECTION 3.** The Dakota Baptist Convention shall determine its order of business at the first session of the Annual Meeting.
- SECTION 4. Special sessions of the Dakota Baptist Convention may be scheduled. The president working with the Executive Board may call the Dakota Baptist Convention into special session if it deems it necessary. The Dakota Baptist Convention in session can call for a special session by a majority vote.
- **SECTION 5.** The minutes of the annual Meeting shall be received by the Executive Board at its formation meeting following the Annual Meeting.

ARTICLE III - OFFICERS

- **SECTION 1.** The officers of the Dakota Baptist Convention shall be president, vice president, recording secretary and assistant recording secretary. The office of treasurer shall be filled by the Executive Director-Treasurer of the Dakota Baptist Convention for an indefinite term.
- SECTION 2. Officers shall be chosen annually from messengers in attendance at the Annual Meeting. Officers shall be members of cooperating Dakota Baptist Convention churches. Nominations shall be from the floor. Election shall be by ballot except when there is a single nominee for an office. In the latter case the president shall instruct the secretary to cast an unanimous ballot for the nominee.

SECTION 3. Employees of the Dakota Baptist Convention, its boards and agencies are not eligible to serve as elected officers of the Dakota Baptist Convention, with the exception of the Executive Director-Treasurer who serves an indefinite term.

SECTION 4. Officers shall serve for one (1) year and hold office until their successors are elected and qualified; however, no officer may serve more than two (2) complete successive terms in the same office except the recording secretary and assistant recording secretary. Terms of office shall commence at final adjournment of the Dakota Baptist Convention in session at the time of their election and terminate at final adjournment of the succeeding regular sessions of the Dakota Baptist Convention. In case of death, disability of, or other cause making necessary the retirement of the president, the vice president and recording secretary shall succeed in order. The Executive Board shall determine when an office is vacant due to the disability of an incumbent.

SECTION 5. The president shall preside over the deliberations of the Dakota Baptist Convention and shall perform such duties as may be customary to the position or as determined in the Constitution/Articles of Incorporation and Bylaws of the Dakota Baptist Convention and shall, by election, become an ex officio member of all Dakota Baptist Convention committees and boards. The president is empowered to appoint the vice president to serve as ex officio member with vote of any committee or board in his/her absence.

SECTION 6. The vice president may, in the absence of the president or when requested by the president, preside over the Dakota Baptist Convention meeting and shall perform such other duties as may be provided in the Constitution/Articles of Incorporation and By-laws of the Dakota Baptist Convention or as requested by the president.

SECTION 7. The recording secretary shall produce accurate and faithful and timely minutes of all sessions of the Dakota Baptist Convention. The minutes shall be published in suitable form in the Annual of the Dakota Baptist Convention together with such other information as the Dakota Baptist Convention or the Executive Board deems necessary and proper. The assistant recording secretary will assist in these duties. The office of the Executive Director-Treasurer may provide assistance as needed.

SECTION 8. The presiding officer may appoint a parliamentarian to assist if the presiding officer deems it necessary.

ARTICLE IV - EXECUTIVE DIRECTOR-TREASURER

SECTION 1. The Dakota Baptist Convention shall employ as Executive Director-Treasurer as its chief executive officer and treasurer. He shall provide spiritual leadership for the total program of the Dakota Baptist Convention.

SECTION 2. When a vacancy of the Executive Director-Treasurer position occurs, the Administrative/Personnel committee of the Executive Board of the Dakota Baptist Convention shall recommend a candidate for the position of Executive Director-Treasurer to the Executive Board. The Administrative/Personnel Committee of the Board will serve as the Search committee, and will bring a recommendation to the Executive Board. A two-thirds (2/3) vote of the Executive Board is necessary to elect a candidate. With permission of the candidate, the Executive Board shall release biographical data to the churches of the Dakota Baptist Convention. When a vacancy occurs the Executive Board may select an interim Executive Director-Treasurer to serve until the Executive Board acts to elects a successor.

SECTION 3. A position description in the Dakota Baptist Convention Salary Administration Plan shall describe the tasks and responsibilities of the Executive Director-Treasurer.

SECTION 4. The Dakota Baptist Convention in session may terminate the Executive Director-Treasurer by majority vote. Or the Executive Board may terminate the Executive Director-Treasurer by two-thirds (2/3) vote of the elected members.

ARTICLE V - COOPERATING CHURCH OR CHURCH TYPE MISSION

A cooperating church or church type mission shall be one that contributes at least quarterly to the work of the Dakota Baptist Convention through the Cooperative Program and reports to the Dakota Baptist Convention each year on the approved and provided forms.

ARTICLE VI – DAKOTA BAPTIST CONVENTION COMMITTEES

SECTION 1. STANDING COMMITTEES

The Committee on Committees shall nominate the Standing committees, including their chairmen, for election by the Dakota Baptist Convention in session. The committees will elect their own secretary. The committees will schedule meetings as needed but should utilize the time around activities of the Dakota Baptist Convention, such as conferences. All committees should review its work and consult with the Dakota Baptist Convention president and Executive Director-Treasurer.

- (a) Constitution and Bylaws. The principle duty of the committee is to review the Constitution and Articles of Incorporation and Bylaws of the Dakota Baptist Convention and the Bylaws of its agencies, and to recommend changes it deems necessary. The committee should present its recommendations to the president and Executive Director-Treasurer by April 1, and to the Executive Board at its spring meeting for review and suggestions, and publish the recommendations in the state Baptist paper or mail to the churches by June 15.
- (b) Nominations Committee. The committee is to recommend members for the Executive Board of the Dakota Baptist Convention and members for the board of directors of the agencies of the Dakota Baptist Convention according to the Constitution/Articles of Incorporation and Bylaws of the Dakota Baptist Convention. A diversity of committee nominees is desired, such as male/female, race, clergy/laity, area of residence instate, number from each church and number from each association. Each nominee will act in the best interest of the total Dakota Baptist Convention work. The nominee does not represent an association, church, or any other entity. He/she represents the Dakota Baptist Convention. A full report is to be sent to the Executive Director-Treasurer for the Book of Reports of the Dakota Baptist Convention by June 1.

SECTION 2. ANNUAL COMMITTEES

Annual committees and their chairman are appointed by the president of the Dakota Baptist Convention within thirty (30) days following the Annual Meeting.

- (a) Annual Session/Program Committee. The committee is to plan the program and future sites for the Annual Meeting. The Program Committee of the Dakota Baptist Convention shall consist of the president, vice president, secretary, the Executive Director-Treasurer of the Dakota Baptist Convention, the Office Manager of the Dakota Baptist Convention, the host association or the host pastor, the Dakota Baptist Convention WMU president, and the president of the Pastor's Conference. They will also assist in enlisting program personnel, assist the president in amending the order of business during the Annual Meeting, and assist with other related matters as requested. The committee is to select an adequate site for the Annual Meeting of the Dakota Baptist Convention, considering the rotation of cities for the Dakota Baptist Convention, availability of local Baptist families to host messengers, adequate meeting space, and adequate hotel/motel rooms. The committee will name the Annual Meeting preacher and the alternate for the next Annual Meeting. The Executive Board will recommend to the committee the times and dates of the Annual Meeting two to five years in advance.
- (b) <u>Credentials Committee.</u> The committee is to certify messengers from churches of the Dakota Baptist Convention. They will present messengers with badges, ballots, and materials for the execution of their duties. The committee will also assist the president in all balloting, certifying votes, and elections, and assist in related matters as requested.
- (c) <u>Committee on Committees.</u> The committee is to recommend committee members according to the requirements of the Articles of Incorporation and Constitution, and Bylaws. They are to gather suggestions from the churches, including biographical data, and if possible schedule an interview by one of the members with the candidate.
- (d) Resolutions Committee. The committee shall review all properly submitted resolutions and shall present resolutions to the Dakota Baptist Convention for its consideration. All proposed resolutions to the Dakota Baptist Convention are to be submitted in writing. The committee may reword resolutions for clarity, combine like issues into one resolution or reject resolutions which have been previously addressed or are inappropriate.

ARTICLE VII - EXECUTIVE BOARD

Organization

SECTION 1. The Executive Board shall organize itself and elect its officers upon the adjournment of the Annual Meeting. The organization shall include an Administrative/Personnel Committee, Finance Committee, and Missions/Programs Committee. With the exception of the Administrative/Personnel Committee, each committee will have at least six members. The chairman of the Executive Board will recommend appointment of the committee members to the board for approval. The Board may establish other committees as needed. Each committee member will act in the best interest of the total Dakota Baptist Convention work. The committee member does not represent an association, church, or any other entity. He/she represents the Dakota Baptist Convention.

SECTION 2. <u>Number of Members</u>. The Executive Board shall be composed of fourteen (14) elected members and two (2) ex-officio members (Executive Director and President).

SECTION 3. Administrative/Personnel Committee. The Executive Board shall establish an Administrative/Personnel Committee, which shall meet as necessary between sessions of the Executive Board. The Administrative/Personnel Committee shall perform the duties assigned to it by the Executive Board. The Administrative/Personnel Committee is made up of six (6) members of the Executive Board, the Executive Board Chairman, and the Executive Director-Treasurer. The specific duties of the committee are to act between sessions of the Executive Board as assigned, monitor and recommend policies of the Dakota Baptist Convention, help prepare the Board agenda, recommend the Executive Board organization and temporary work groups, supervise the Executive Director-Treasurer on behalf of the Board, serve as the search committee for an Executive Director-Treasurer when a vacancy occurs, receive the Executive Director-Treasurer's recommendation of prospective staff personnel and participate with the Executive Director-Treasurer and staff in developing and implementing a long range strategy plan.

SECTION 4. <u>Missions/Programs Committee</u>. The committee is to oversee the functions and work of church development, new work/language missions, evangelism and ministries. The committee will work with staff in long range planning, proposing program objectives and priorities to the Board and in the evaluation of program accomplishments, and approving budget supplements for new mission congregations. The state program directors shall be ex officio members of the committee, but without vote.

SECTION 5. Finance Committee. The committee is to serve as the budge committee of the Board, review, evaluate and recommend financial policies of the Dakota Baptist Convention to the Executive Board, arrange for and review the annual audit and report audit to the Executive Board, study giving trends, review periodic financial statements, and approve line item changes within the budget as permitted by the Dakota Baptist Convention actions. The committee is to propose the Cooperative Program goal and distribution of funds and to recommend the annual goal and expenditures of the state mission offering.

Responsibilities

SECTION 6. The Executive Board is to serve as the Dakota Baptist Convention ad interim and as the Dakota Baptist Convention's principal advisory on its total program. The Executive Board shall not contravene actions or policies of the Dakota Baptist Convention.

SECTION 7. To serve as the Dakota Baptist Convention's operating board for all programs not assigned to other boards.

SECTION 8. To evaluate the performance of the Executive Director-Treasurer of the Dakota Baptist Convention, and to assist him in the exercise of his duties as chief executive officer and spiritual leader in carrying out the programs of the Dakota Baptist Convention.

SECTION 9. To act as fiduciary and fiscal agent of the Dakota Baptist Convention in all matters not assigned to agencies' board, to execute any and all deeds, mortgages, deeds of trust, assignments, or other conveyance that the Executive Board may deem proper in its official capacity.

SECTION 10. The Dakota Baptist Convention herewith empowers and directs the Chairman of the Executive Board and its Executive Director-Treasurer to sign in official capacity for the Dakota Baptist Convention all such aforementioned deed, mortgages, deeds of trust, assignments, or other conveyances.

SECTION 11. All gifts of money other than the general budget of the Dakota Baptist Convention or other property made to the corporation shall be disbursed according to the donor's designation. The corporation shall have the power at all time to accept or reject designated gifts. Undesignated gifts shall be distributed in accordance with the corporation's budget.

SECTION 12. To act upon the recommendations of the Nomination Committee to fill any vacancies occurring between Annual Meetings.

SECTION 13. To have oversight of the arrangements of the Dakota Baptist Convention sessions.

SECTION 14. To present to the Dakota Baptist Convention a proposed budget for the forthcoming year. The Finance Committee of the Board shall serve as the budget committee. The Executive Board shall publish and distribute to all the churches of the Dakota Baptist Convention copies of the proposed budget at least thirty (30) days before presenting it to the Dakota Baptist Convention in its Annual Session for final approval.

SECTION 15. To establish and revise policies relating to the duties assigned to the Executive Board by the Dakota Baptist Convention and to maintain policies manuals. The Executive Board shall work closely with the Executive Director-Treasurer to ensure an organization that is both functional and accountable. The policies manuals are subject to the review and amendment of a simple majority of the Executive Board.

SECTION 16. To be responsible for long range planning of the Dakota Baptist Convention and its programs and to coordinate the long rang planning of an agency's board with the total Dakota Baptist Convention program.

SECTION 17. To assist the Finance Committee in the fulfillment of their duties, in the audit of the Dakota Baptist Convention's financial records, to receive and publish their reports in the Book of Reports, and to act upon their recommendations concerning the management of the accounts.

SECTION 18. to approve and to employ board approved staff personnel upon recommendation of the Executive Director-Treasurer and the Administrative/Personnel Committee. The Executive Board shall approve personnel policies.

SECTION 19. Members are expected to attend all Executive Board committee meetings and plenary sessions. Failure to do so may result in their removal by the Dakota Baptist Convention in session. Each member is responsible for notifying the chairman of the Executive Board or the Dakota Baptist Convention office in case of an emergency necessitating an absence.

Meetings

SECTION 20. The Executive Board shall meet at least three times a year on dates suggested by the Executive Director-Treasurer and approved by the Executive Board and at additional times as determined by the Board. The organizational meeting of the Executive Board shall be held following the Annual Meeting.

SECTION 21. The Executive Board may be called into special session by the Administrative/Personnel Committee.

SECTION 22. A majority of the elected Executive Board shall be considered a quorum.

Reports

SECTION 23. The Executive board shall prepare and publish a comprehensive report of the affairs of the Dakota Baptist Convention and a summary of the actions taken by the Executive Board in an Annual Book of Reports.

SECTION 24. The Executive Board shall publish a summary of the Executive Board actions in the state Baptist paper after each session.

ARTICLE VIII - AMENDMENTS

Amendments maybe made in these Bylaws by a simple majority of the messengers present when the vote is take without regard to total enrollment at any Annual Meeting of the Dakota Baptist Convention, provided (1) no amendment may be considered after the second session of the Dakota Baptist Convention, (2) and that the proposed change be submitted in writing to the Dakota Baptist Convention office and the Constitution and Bylaws Committee at least one hundred twenty (120) days prior to the Annual Meeting and published in state Baptist paper or mailed to the churches ninety (90) days prior to the Annual Meeting.

Dakota Baptist Convention October 21 – 22, 2004

Annual Meeting Minot, ND

Session I

DBC President, Vel Hightower welcomed everyone and read letters from the Alabama State Convention and California Southern Baptist Convention. Both conventions sent their greetings and prayers.

Vel Hightower called the 21st Annual Meeting to order at 6:05pm. (1st as a Convention but 20 others as a Fellowship)

Seating of Messengers: James (Budg) Riekeman of the Credentials Committee brought the recommendation to seat all those messengers (58) that have registered at this time. Motion passed.

There were some churches that were not allowed to seat messengers (these had been contacted prior to this meeting) and Vel stated that this was a reminder for us all to be more faithful to the constitution and be diligent with our reports and offerings. He also stated that as Chairman, if a person who was not allowed to be seated desired, he would allow them to speak but not to vote. Business needs to be conducted in the spirit of Christ and not addressed to individuals. If there were any additional motions to be added under new business tomorrow, the written motion(s) need to be given to the reporting clerk tonight. This would assist in time allocation tomorrow.

Adoption of the Order of Business: There was no response to the request for any discussion concerning the Order of Business. Motion to approve the order of business. Motion passed.

Dr. Jim Hamilton expounded on the theme interpretation of Acts 1:8 – Empowerment. We should allow the power that God has given us to be explosive. It should not take 40 - 85 people to win one person to Christ.

Bruce Knight, Cross Roads Baptist Church, Minot delivered the opening prayer.

New Business: 1) The budget, printed on the pink sheets in the book of reports, needs to be reviewed before voting on during tomorrow's session, 2) Resolutions – need to be in written form and given to recording secretary tonight.

Worship / praise songs were lead by Scott Grimm with special music provided by Abigail Hamilton.

President Hightower's Address: (Passage John 10:11-14)

The message spoke to being Under Shepard's to the Great Shepard. He spoke to the pastors about taking the risks necessary to stick it out when things get tough. Must have a heart for your sheep – compassion for the people and embrace the location. Make the Dakotas home. Become a "passionary" — a pastor and missionary filled with compassion all rolled into one.

Recognition of New Pastors and DBC Staff:

Association Missionaries: Buck Hill, Jim Pratt, Garvon Golden

New pastors: 10 new pastors were introduced – not all were able to attend.

Dr. Hamilton introduced the keynote speaker, Dr. J. Robert White, and his wife, Janice. Dr. White is the author of "Healthy Kingdom Churches".

Dr. White shared information associated with Empowering Kingdom Growth, revival, and baptism growth. He highlighted several qualities of healthy churches: 1) singleness of heart – Unity, 2) filled with the Holy Spirit – don't be afraid to give credit to the Holy Spirit for the power that you are given, 3) steadfast commitment to preaching the Word / the Gospel, 4) stewardship – cheerfully, and 5)

praising God – compel the lost to come in so that they can be reached through the Gospel. Get back to the basics of the early church – an Acts church.

Vel invited everyone for breakfast the next morning. There were refreshments available for fellowship time at the conclusion of Session I. Session I adjourned at 8:42pm.

Session II Friday, October 22, 2004

President Vel Hightower welcomed the session to order at 9:10am.

Dr. Jim Hamilton presented the second theme interpretation of Acts 1:8 – Employment. We work for God and we must work together. Being witnesses is the essence of our job description.

Prayer requests from within our Convention were requested. Requests received were for a newborn baby with complications, Colton; Alice Miller's family as she had passed away; Frank Alexander and Charles Hall with health concerns. Garvon Golden led the prayer for our Local Communities.

Credentials Committee, Budg Riekeman, presented an update on the messengers in attendance, 69 messengers from 31 churches.

Nominations Committee, Bob Hower, presented the following recommendation for changes on the Executive Board:

- Be it resolved that we affirm and support Dr. James Hamilton, our new Executive Director. We challenge our churches and members to pray for him and the Dakota Baptist Convention staff regularly and support their leadership.
 - a. No discussion. Motion carried.
- 3. Be it resolved that we appeal to Dakota Baptist Convention churches and members to pray regularly and fervently for our Strategic Planning Team as they formulate strategies that will support and guide our churches to achieve Acts 1:8 goals.
 - a. No discussion. Motion carried.
- 4. Be it resolved that we encourage all Southern Baptists in the Dakota Baptist Convention to exercise their right to vote in the upcoming election. We challenge them to be intelligent voters and to support candidates who most closely follow the values taught in the Word of God.
 - a. No discussion. Motion carried.
- 5. Be it resolved that we affirm the Biblical design of marriage as the union of one man and one woman for life. It is our conviction that the laws of our states and nation should reflect this Biblical design. We challenge our churches and members to live and promote this truth.
 - a. No discussion. Motion carried.

Annual Sessions/Program Committee Report, presented the recommendations for the next three (3) years, stating the locations, dates, preachers and alternates. It was explained that Roger Crowhurst was not able to bring the sermon this year and Bruce Knight would be preaching instead. Dr. Jim shared that

Rob Grimm's work load and duties as Board Chairman were taken into account so as to not overload him on short notice. Motion carried.

Prayer for the Dakotas was lead by Sally Jezek.

DBC Staff Reports – started with a skit – humorous and meaningful. The skit shared that we sometimes get hung up on "not my area, not my job". We have all been called to go into the world and do our jobs. Now we need to get up and do it. Staff reports in the crème colored section of the Book of Reports were presented by Dr. Jim to Vel. Myron also shared that there were new things coming in the future with the website (thedbc.org) – possibly the DBC Christian Radio. No questions.

Foundation Report – Dr. Jim explained that there had been some resignations from the board for personal reasons. The foundation is established but it needs some work. No questions.

Executive Board Reports – Rob Grimm presented the reports, green colored section, and a challenge – that no matter what, we work together. No questions.

Moved to accept reports for adoption. No discussion or questions. Motion carried.

Prayer for the Nation was lead by Budg Riekeman. Another prayer request was added for John Sneed's wife for health problems.

Program Presenters:

NAMB – Eric Ramsey brought greetings from Dr. Bob Reccord, recognized NAMB funded positions in the DBC, shared mission program highlights, and thanked the DBC for their participation and seven new church starts.

LIFEWAY – Neil Knierim brought greetings from Dr. Draper. There has been a renewed emphasis on SS and Discipleship materials. There will also be a second line of VBS materials each summer – the 2nd line being more in the club type materials. The main VBS theme is Ramblin Road Trip and the club is Beach Blast. Encouraged people to share what works and what does not – changes can and are made from information received from the churches. Thank you for purchasing from LifeWay.

GuideStone Financial Resources – Don McLeod gave all a free book on Philemon. GuideStone is the new name for the Annuity Board. They are there to help provide Protection and Survivor benefits. He explained several budget level options. He also encouraged any church/pastor that could not put even \$1 towards the annuity fund to contact him.

Prayer for the World was led by John Wisinger.

Program Presenters:

WMU—Janet Hoffman, WMU President, thanked the DBC churches for sending our top ladies to serve. She listed five (5) strategies for partnering: 1) pray for and give to the missions, 2) do missions, 3) learn about missions, 4) develop spiritually to a mission's lifestyle, and 5) participate in the work of the church and denomination.

SBC Executive Committee – Will Hall, shared that he was part of the professional staff who plans and manages the SBC annual meeting, the Baptist Press, and SBC life. They have the responsibility of interpreting SBC beliefs and doctrines to the world and sometimes even Southern Baptists. They stress the cooperation between Baptists. He also shared that there had been \$189million given to the

Cooperative Program with another \$189million given as designated funds. The challenge this year is to baptize one million people.

IMB – Hal and Brenda Hostetler, who hale from Jamestown, ND, shared that they had served as missionaries for 25 years in the Caribbean – Trinidad. They serve through SS, VBS and music. They are witnesses by being involved. They encouraged us all to become involved.

Annual Sermon, delivered by Bruce Knight, Cross Roads Baptist Church Minot.

A notes page was handed out. Message title – The Call to the Dakotas. Scripture reference was Amos 7:14-15. Amos did not run – he stood and preached the tough stuff. The 5 points of his message were; The Call of God 1) not a profession I chose, 2) not a product of family tradition, 3) came when I was pickin' figs, 4) God picked me, and 5) God placed me. We are to remember the call – the call from God.

Bill Savery delivered the closing prayer from Daniel 9. Dismissed at 12:40pm for lunch.

Session III Friday 2:00pm

Lon Cockerill opened the session with prayer. He also shared a very rewarding experience – the reading of the Bible in 70 hours, read by many readers.

Dr. Hamilton shared the last theme interpretation, "Embracement". It is not about the geography but rather the mentality of how we / our churches are going to embrace reaching out.

New Business: Luke Bell would like to see the deacons establish a group to address the responsibilities they have to the pastors and the churches.

Resolution committee (Dude Garrett) presented Resolution #6 as a motion:

Whereas Midwestern Baptist Theological Seminary established a seminary extension campus in Rapid City, SD, utilizing the facilities of a non-Southern Baptist Convention church and the services of a non-Southern Baptist president; and

Whereas Midwestern Baptist Theological Seminary acted outside established protocols that govern fraternal cooperation between Southern Baptist Convention entities by neglecting to coordinate this initiative with The Dakota Baptist Convention;

Therefore, be it resolved that The Dakota Baptist Convention in annual session expresses our disappointment over the failure of Midwestern Baptist Theological Seminary to work with our convention to establish theological education in the Dakotas;

That Midwestern Baptist Theological Seminary actions undermine our effort to establish a strong Southern Baptist presence in an emerging region of our nation;

That under these circumstances at this time we cannot support this Midwestern Baptist Theological Seminary effort;

That our Executive Director, Dr. James Hamilton act at his discretion to communicate our concerns to Midwestern Baptist Theological Seminary staff, trustees, and the SBC Executive Committee. Discussion: Dr. Hamilton shared that protocol has not been followed, and also that Cooperative Program funds which help support the Seminary are being used outside a Southern Baptist sponsored entity. Having an extension is okay but the real dream of the convention is to have a DBC college. This resolution will give Dr. Jim more authority to address this issue. Stan Bricker, Spearfish, SD, stated that there is a member of their congregation that is currently attending this extension and he hopes that this will not cause conflict. He hopes it can be resolved in a nice manner.

Garvon Golden called for the question. This motion is to stop the discussion. Motion to cease passed. The vote on the resolution was taken. Resolution motion passed.

Adoption of Budget: Larry Thompson of the Finance Committee moved for the adoption of the budget as presented.

Discussion: Dr. Jim wanted to apologize to the DBC for not providing this type of information. This is a unified budget not compartmentalized. The DBC will actually have a smaller budget for operations but will be working to get more money into the churches and associations. Motion passed.

Election of Officers:

Dear Board Members:

Thank you for the opportunity to audit the financial records of the Dakota Baptist Foundation (DBF) and Church Loan Fund for the fiscal year ended December 31, 2004.

Although the Church Loan Fund is considered a part of the Foundation financial system and the Fund is administered by the Foundation Board, the Balance Sheets of the Foundation and the Church Loan Fund have been presented separately to better show the results of operations. Future statements should show a combined Balance Sheet for both the Foundation and the Church Loan Fund.

The last known audit of the DBF was done by Scott Holt, Accounting Director, Florida Baptist Convention for the fiscal year ended December 31, 1999. During the next five years staff leadership for DBCF changed several times. These changes included several DBC Executive Directors, several bookkeepers as well as a change in the software used for the accounting system. These changes, along with misappropriation of funds by a staff member made it difficult to track and trace the various transactions throughout this time period. However, Mrs. June Highlan, an experienced bookkeeper with tremendous knowledge of ACS financial software and Convention accounting practices was contracted by DBC to bring the transactions of DBF up to date. Her work culminated in a report to the DBF board on April 8, 2005 which listed eleven recommendations.

I have reviewed Mrs. Highlan's work thoroughly and have incorporated her recommendations into the Balance Sheets of the DBF and Church Loan fund. Because of the complexity and interrelatedness of some of the transactions between DBF, DBC and the Church Loan Fund caused by the misappropriation of funds, a Statement of Activities has not been included for either DCF or the Church Loan Fund. However, future financial statements should include a Statement of Activities which details investment income, loan income, contributions or gifts and any expenses related to DCF or Church Loan Fund.

The scope of my audit included examining the accounting records of the Dakota Baptist Foundation and Church Loan Fund for the fiscal year ended December 31, 2004 to determine the accuracy and efficiency of the accounting/financial system and whether any deficiency of internal controls exists. I also examined limited transactions documentation for the years ended 2001, 2002 and 2003.

Because I am not a Certified Public Accountant, I cannot express an official opinion on these financial statements. However, I believe the Balance Sheets presented fairly reflect the results of cash transactions for the Dakota Baptist Foundation for the fiscal year ending December 31, 2004.

Notes to Financial Statements

NOTE A – NATURE OF ACTIVITIES

The Dakota Baptist Foundation (Foundation) is a not-for-profit organization which receives, manages and administers gifts for Baptist causes from individuals and entities and establishes permanent endowment and trust funds to perpetuate a Christian witness. The Foundation also operates a church loan program which assists Southern Baptist churches in the purchase of new church sites, repairs to an existing building, small additions, furnishings or parking lots.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

These Balance Sheets have been presented substantially on the basis of cash receipts and disbursements except for amounts owed to or from related entities. Operating funds consist of expendable funds that are available for support of the Foundation's activities. Temporarily Restricted Funds are trust funds that substantially benefit the donor or other Baptist related organizations.

Income Taxes

The Dakota Baptist Foundation is a nonprofit organization for the purpose of receiving and distributing charitable donations. The Foundation is exempt from federal income taxes under Section 501 (C) 3 of the Internal Revenue Code.

NOTE B – DUE FROM DAKOTA BAPTIST CONVENTION

Amounts paid on behalf of the Dakota Baptist Convention by the Foundation were identified by June Highlan in a report to the Board in April 2005, Exhibit D in the amount of \$18,128.33. Additional expenditures made on behalf of Richard Farley were identified in that same report, Exhibit C, in the amount of \$7,995.19. These amounts are combined on the Balance Sheet as a receivable from the Dakota Baptist Convention because a petition will be made to recover these amounts from the Convention.

NOTE C – DUE TO/FROM DAKOTA BAPTIST FOUNDATION

During 2002 \$109,500 were withdrawn from the Foundation savings account, but were not deposited in the Foundation checking or other investment accounts. Instead, the funds were deposited into the Dakota Baptist Convention general budget account as detailed in Exhibit 5 of June Highlan's analysis. Because of a lack of cash in the Dakota Baptist Convention, the Board adopted Recommendation 4 in April 2005 that seeks to restore those funds from the Church Loan Fund. Accordingly, a Due from Church Loan Fund in the Foundation Balance Sheet and a Due to Foundation in the Church Loan Fund Balance Sheet in the amount of \$109,500 has been posted.

NOTE D - NOTES RECEIVABLE - NEW HOPE BAPTIST CHURCH

In August 2003, the Board voted to write off the balance of the loan to New Hope Baptist Church, Aberdeen because the church had ceased to exist. However, the loan was never written off the books of the Church Loan Fund. Recently, a group has begun a new start and has begun using the building. Subsequent to the Balance Sheet date, the Board voted in April 2005 to permit the new congregation to submit a statement of the expenditures incurred in refurbishing the building and grounds and that that amount should be deducted from the loan balance. The Board also voted that the adjusted amount would be repaid by the church at the current prime rate. Therefore, the balance of the loan remains on the books at December 31, 2004.

Dear Board Members:

Thank you for the opportunity to audit the financial records of the Dakota Baptist Foundation (DBF) for the fiscal year ended December 31, 2004. I would like to offer a special word of appreciation to Dr. Jim Hamilton, Mrs. June Highlan and other DBC staff that provided me information and documentation with which to complete the audit.

As with any accounting system, improvements can be made to the policies, procedures and processes that are followed. Small organizations have a special challenge to provide enough separation of duties to have an adequate system of internal control. Listed below are suggestions that will improve the financial system of DBF.

- I recommend that a policy and procedures manual should be proposed by the administration of DBC and be approved by the Board that outlines how receipts, disbursements and reporting will be done. In addition procedures should be detailed for the processing of church loans and grants. This step will hold the financial system to a standard that everyone understands and to which everyone agrees.
- 2. When examining documentation related to the Foundation accounting system, documents seemed to be scattered throughout Convention offices. I recommend that all documents related to the Foundation be consolidated in one place or office and organized so that research on accounting transactions can be easily accomplished.
- 3. In September 2003 the Foundation Board considered a new Articles of Incorporation/Constitution document and an Operating Procedures document. In light of the financial realities recently revealed to the Board, I recommend that Board review those documents to be sure they reflect the desires of the Board.

The adoption of the above recommendations will serve to strengthen further the financial processes of the Dakota Baptist Foundation.

MINUTES DAKOTA BAPTIST CONVENTION FOUNDATION BOARD OF DIRECTORS APRIL 8, 2005

The meeting held at a conference room at the Comfort Inn in Rapid City was opened with prayer led by Jim Hamilton. Present for the meeting were: Henry Kaelberer, Bill Savery, Debbie Holmes, Jim Hamilton and June Highlan with Bruce Knight participating through video conferencing.

Each person received a binder which included the following:

1. A review of the reports and balances as managed and reported from 2002 - 2004.

- Review of the Savings Accounts held by the Foundation and Church Loans from 2002 2004 and the activity and transactions within those accounts.
- Church Loans from 2002-2004 as re-entered.
- Foundation from 2002-2004 as re-entered.
- 5. Items for Review
- 6. Activity in Church Loans & Foundation Jan-Mar, 2005.

After an introduction by Jim Hamilton, June Highlan who is employed by the Dakota Baptist Convention as bookkeeper reviewed the contents of the binder. Highlan had analyzed the activity of the Foundation from 1999 thru 2004, and had decided that because of what was revealed that it was best to re-enter 2002, 2003 and 2004. After the documentation presented was examined in detail, the following recommendations were adopted:

CHURCH LOANS:

- Henry Kaelberer moved that the amount of expenses over income of \$34, 893.12 for the period 1/1/2002 to 12/31/2004 as detailed in Exhibit 6, be posted to the Restricted Loan Fund Balance. These expenses were Dakota Baptist Convention expenses which were paid from Church Loan funds. Bill Savery seconded the motion and it was approved.
- It was motioned by Debbie Holmes and seconded by Bruce Knight to combine the two (2) Loan Fund Balance Accounts [50-3510] & [50-3550] into Account [50-3510, Restricted Loan Fund Balance and to write off \$37.50 in Accounts Payable [50-2500] which had appeared on the books since 1999. Motion passed.
- 3. Bruce Knight moved that the Dakota Baptist Foundation be paid \$109,500.00 from Church Loan Restricted Funds to recover funds withdrawn by the Dakota Baptist Convention. As reviewed in the activity examined by the committee in 2002, \$109,500.00 was withdrawn from the Foundation and deposited in the DBC General Budget Account. There was no authorization for the withdrawal or expenditure of Foundation funds. The committee desired that the record show that these funds should have been recovered from the DBC General Budget but because of the circumstances that the Convention is under due to the financial mismanagement of its funds it would be an unattainable burden for the Convention. Henry Kaelberer seconded the motion and it passed.
- 4. In September, 2002, the New Hope Baptist Church, Aberdeen, disbanded and left the Church Loan Fund with an unpaid loan balance of \$40, 933.77. That amount remains on the books as the balance 12/31/2004. In recent months a group has began new start and they have been using the building and have invested materials and labor in the building. They have contacted Jim Hamilton through the Associational Missions Director Buck Hill requesting that the property be returned to the current congregation. Note: The title to the property passed into the possession of the Foundation on January 31, 2003. Debbie Holmes moved that the present congregation submit a statement of the expenditures incurred in refurbishing the building and grounds and that amount be deducted from the \$40,933.77. The adjusted balance would be the amount to be paid by the church at the current prime rate. Motion was seconded and passed.
- By consensus approved writing off \$219.70 [Account 10-210] which had been on the books for several years.
- From the period 2002-2004, \$26,123.52 [Accts 10-1300 & 10-1330] as detailed in Exhibit C & D was paid from Foundation Funds. These expenses were not related to the Foundation. These were misappropriated from the Foundation. Bill Savery moved that the Dakota Baptist Convention be petitioned to reimburse these funds to the Foundation from the money Richard Farley is reimbursing the Convention. Motion was seconded by Debbie Holmes and approved.
- 7. The CD held at the Louisiana Employees Credit Union matured in March, 2005. The funds were returned to the Dakota Baptist Convention. Note: The funds of the Foundation, Church Loans and DBC were consolidated at the LA Credit Union, therefore, they were deposited with the Convention to be transferred (April 11, 2005) into their respective accounts: \$21,690.19 to the Foundation Checking Account, \$100,372.45 to the Church Loans Checking Account with \$754.37 remaining with the DBC. The funds returned from the LA Credit Union also included \$1,891.13 in earned interest. Debbie Holmes moved that the interest be prorated and distributed to each of the accounts. Note: That distribution was as follows: Foundation \$333.97, Church Loans \$1545.43 and DBC General Budget \$11.73. In addition, after the distribution of \$109,500.00 from Church Loans to the Foundation is processed, the funds not needed in the checking account be invested with the Southern Baptist Foundation. This motion was seconded by Henry Kaelberer and approved.

The committee was adjourned and closed with prayer led by Bruce Knight.

Missions Report Dakota Baptist Convention John Guillott

Report to the Executive Board Myron Grueneich DBC Strategic Coordinator/Church Health and Leadership Development August, 2005

Keep watch over yourselves and all the flock of which the Holy Spirit has made you overseers. Be shepherds of the church of God, which he bought with his own blood.

These were the words of Paul to the Ephesians elders as he left for a new ministry. Paul uses two words (flock – shepherd) that strike dear to my heart. Having been a shepherd with a flock of real (wooly) sheep for 29 years, I understand the depth of what Paul is saying. Now working with a larger flock, (God's flock) I am amazed at the vastness of the calling.

There are many threats to the flock. It seems the flock is fragile and vulnerable. It seems the flock is easily led, easily deceived, easily divided, and easily enticed. So God places shepherds to oversee. God has placed in me a shepherd's heart. So I wrestle with some of the same things Paul did. I ask God shepherd questions.

Father, how can we do real ministry and not just programs?
Father, what will it take to see spiritual awakening in the Dakotas?
Father, how can the state convention office touch lives more effectively?
Father, how can we be the shepherds you want us to be?

I sense God is setting the stage for something special for the Dakotas. I see him calling people to himself in a profound way. I see pastors and churches intentionally and passionately growing God's kingdom. I see lay people with a growing desire to serve God in a new and vibrant way. I see new leadership seeking mentorship and training. I see a heart for prayer and repentance. I see the brethren loving one another. God is growing us in new and exciting ways!

God has called me as part of our state team to resource and support local and associational ministry. We have awesome and untapped resources available from IMB, NAMB, LifeWay, other ministry partnerships, and other state conventions. But all of the resources are valuable *if* they touch the local church's unique needs and ministry. Our ultimate goal is not training but equipping, doing not just knowing. We need to move every believer and every church to the next level.

I approach state convention ministry from the perspective that our reach is limited. It is impossible for one person to effectively serve 90 churches in all the areas of strengthening ministry. Enlisting other leaders who possess a passion and surrender to God's call to grow healthy churches and leadership will anchor my strategy. Those who work the closest to the church have the greatest influence so we will make every effort to partner with those God has already called to serve.

I have oversight in four major areas as blueprinted in our Strategic Plan. The first is discipleship. I believe we must do a better job of growing "Christ-followers". Much of the challenge of today's church is to grow mature believers. Becoming saved is the beginning not the end. If we had as many true disciples as we do baptisms we would be a completely different

convention today. The back door seems as big as the front door. Multiplying true disciples of Jesus Christ will affect spiritual renewal in a profound way. Every church needs an intentional plan to grow mature believers.

Secondly, we need to foster selfless ministry. We need to mobilize more people to serve in relevant ministry across the Dakotas. Our churches need to be filled with people who understand their giftedness and calling and respond in meaningful service. Every ministry must stand on its own merit and should be results oriented.

Thirdly, we must develop and nurture current and new leadership. Our future hinges on the development of pastoral and lay leadership. One vital component of moving churches to the next level is the growth of our leadership. We must follow Christ's example and invest in the lives of a few who will in turn reach the crowds. We must also work to stabilize and support those faithful servants God has placed in leadership.

Lastly, but at least equally important is integrity. We need to walk in integrity. Dakota people care about this vital issue. It is apparent that we know what we should do but have not always done it. Dr. Hamilton has taken steps to restore integrity to the state office. But integrity does not start or end there. Pastors, churches, lay leaders and associations across the Dakotas deal with integrity issues. There are stewardship issues, moral issues, ministry issues, and relationship issues. Power struggles, gossip and false witness, leadership failures, and marriage and family issues challenge our integrity at every level of the DBC. We need to permit others to hold us accountable to Biblical principles of integrity in a loving way. We need to shake off the old way of doing things when it lacks integrity. God cannot bless that which is contrary to His character.

I am humbled by this opportunity to serve in this way. I am still working on being a little more "Southern" but I confess I am really a hometown Dakota guy. I count it a privilege to work alongside so many Godly men and women who serve our Lord so graciously and faithfully. I am grateful for Dr. Hamilton's leadership and my fellow staff. I am blessed to serve this "flock" for this time.
