#### State Staff Study Task Force Report Summary

#### Introduction

In recent years the Southern Baptist Convention has seen a radical restructuring of how we fund shared ministries. This change has had a dramatic impact on the DBC budget. At one time we had an annual operating budget of more than one million dollars, funded 95% by the supportive partnerships of the North American Mission Board and LifeWay and 5% through the Cooperative Program giving of our churches. Over the past decade these partnership dollars for supporting the general work of the DBC have declined.

Garvon Golden, our former state Executive Director/Treasurer, recognized this trend and in 2018 led the Convention to develop a task force to assess the staff structure of the DBC and design a healthy response to support Kingdom work in and through the Dakotas. The Executive Board authorized this task force to look into the future of our state convention operations. We studied the questions of how to staff our state convention without outside resources.

More recently, financial fallout from the 2020 COVID-19 pandemic has impacted the immediate and future ability of our partners, NAMB and LifeWay, to continue their financial support. This new reality has magnified and accelerated the need for the DBC to design this new cooperative model.

#### Impact of NAMB and LifeWay Funding Changes

These changes have, understandably, impacted how state conventions operate. The task force researched how they have affected the DBC in the past ten years. The results were interesting.

Note that, while NAMB significantly decreased support to our annual budget, our Cooperative Program giving increased by 155% in nine years. For additional perspective, in 2003, the year we changed from being a fellowship to becoming a convention, CP giving was \$195,563. Our churches are growing in stewardship.

As our strategic cooperation agreements with NAMB have progressively changed, the stewardship health of the DBC has improved. NAMB "cutting" funding from our budget actually helped us grow in financial responsibility. Other health metrics such as worship attendance and Sunday School attendance have also grown. The only common method of assessing health that has not grown is baptisms, which is an SBC-wide trend that continues to be assessed and addressed.

#### Conclusions

While churches must grow in size, maturity and evangelistic effectiveness and we must continue to plant churches, we conclude that the reduction of NAMB funding from the annual DBC budget has arguably helped our convention grow toward greater maturity. Here is a partial list of positive developments in the last ten years:

- 1) Our budget depends far less on NAMB funding, freeing us to pursue strategies we believe will lead to the long-term health and strength of our churches.
- 2) NAMB remains a strong partner, free to concentrate on effective church planting in the Dakotas. Our new church plants in the past ten years are healthier and more generous new works that strengthen our convention.
- 3) Our convention grew in attendance, in faithful stewardship, in Cooperative Program giving, and in the percentage of CP dollars we pass on to world missions.
- 4) Our state Executive Director is free from the requirement to supervise NAMB personnel, allowing him to concentrate on Dakota Baptist priorities and strategies.

#### Application to 2021 Budget and Beyond

As we prepare the DBC budget for 2021 and beyond, we must plan how we will staff our convention in the coming years. As we think about budgeting, we grapple with the last problem presented by the changes that NAMB started to implement in 2011. The last remnant of NAMB support for our DBC budget amounts to \$50,000 per year for administrative support. NAMB generously provided this money every year without any strings attached. This money helps us staff and resource our state convention. NAMB had been signaling changes to this arrangement, which would likely decrease, eliminate, or restructure this support. Then, the 2020 COVID-19 pandemic occurred. In response, NAMB has determined that this support will continue at the present level through the end of 2020, be reduced to \$25,000 for 2021, and then permanently discontinued beginning January 1, 2022. NAMB has also recently determined that they will be able to continue to partner with state conventions by providing church planting development funds and funds to provide evangelism training.

In response to the pandemic, LifeWay immediately froze monthly partnership support of \$5,000 for the rest of 2020. LifeWay has faithfully sent this money to the DBC every year. This money helped us staff our state convention. However, as part of LifeWay's restructuring and streamlining of operations and the continued financial impact of the pandemic, they have been forced to permanently eliminate this support to state conventions.

Now we must decide how to proceed with a likely loss of \$110,000 (approximately 20%) per year from our annual operating budget. Regardless of what our agency partners do in the future, we believe these changes in funding offer more of an opportunity than a crisis. We now have the opportunity to take the final steps in growing up as a convention, stand on our own two feet, and take responsibility for the Kingdom work here in the Dakotas.

#### Proposal to Restructure the State Staff

In light of these results and observations, the task force recommended that the Executive Board adopt a proposal to develop over 3-5 years a team of men with DBC pastoral experience to serve on a part-time contract basis as "Church Relations Missionaries" (CRM). These men will serve a cluster of churches, church leaders, and pastors by fostering their connections with one another and with the Dakota Baptist Convention. The CRMs will receive training in building ministry relationships, understanding the DBC goals, vision, strategies, and resources, and best practices for serving churches. After building this team, the DBC will call an additional full-time state staff missionary to serve as Associate Executive Director. This man will, among other roles, take responsibility for oversight of the CRM strategy.

While a specific covenant will be developed by the Executive Director and each CRM, the role of the CRM will include:

- 1) Visit and maintain contact with churches, pastors, and church leaders
- 2) Encourage pastors, their families, churches, and church leaders
- 3) Assist churches with pastor and church staff searches
- 4) Assist churches in crises and conflict situations
- 5) Resource churches in evangelism, discipleship, and small groups
- 6) Refer and connect pastors and churches to needed resources and expertise
- 7) Facilitate peer groups among pastors as well as personal coaching as needed
- 8) Connect with other SBC agencies when relevant in serving pastors and churches

#### The timeline for implementation will be:

2021: Enlist three regionally-based CRMs to serve throughout the Dakotas

2022: Enlist one CRM to focus on serving our Native American churches

2023-2025: Enlist the Associate Executive Director when the budget allows for it

**Note**: This proposal was adopted at the August 2020 DBC Executive Board meeting. It will take effect January 1, 2021. The budget that will be presented for approval at the 2020 Dakota Baptist Gathering is based upon this new strategy.

Fred shared the background. Due to the impacts of COVID-19, NAMB is honoring their commitment of funds through September 30. Lifeway has frozen all funds. This leaves the DBC with a \$52,000 shortfall in our budget. He also said that it would be a couple of months before we know how much impact this will have on church Cooperative Program giving.

#### The Admin team recommends the following:

- 1. Spend up to \$50,000 from the Unrestricted Fund, if needed (Line 39900) with a balance of \$59,555.49 in April.
- 2. If needed, money will be taken from the Strategic Impact Fund (Line 10545) with a balance of \$122,758.75 in April.
- 3. If more funding is needed, money will be taken from the DBC Reserve Funds (Line 10550) with a balance of \$218,370.50 in April.

Fred reported that we are still on track for CP giving.

John asked if cuts in the budget had been looked at. Fred said not at this point. Goal is to maintain budget as approved.

TJ asked if we are spending less right now. Fred said that he had not looked at the spending numbers, however he said that he anticipated spending would be lower in some areas because of the office being closed for a few weeks, less travel during the restrictions, etc.

The Executive Board approved Recommendation 1 to spend up to \$50,000, if needed from the Unrestricted Fund.

Recommendation 2 was amended to say, the Exec Board will approve an alternate spending plan, with input from the staff.

Motion to amend by John Flowers .

The amendment was seconded by Bob Farmer. The amendment passed.

The Board approved Recommendation 2 to access the Strategic Impact Fund, if there is a CP shortfall.

The Board approved Recommendation 3 to access the DBC Reserve Fund, if even more funding is needed.

In looking ahead to the August Executive Board meeting, where the board will be preparing the 2021 budget, if NAMB and Lifeway do not continue their funding, the DBC will not have \$110,000.00 for the budget.

#### Correspondence from Email Meeting July 21-23, 2020

Original email sent from Fred MacDonald to Executive Board Members with subject line "Executive Board Business Item – time sensitive":

DBC Board members,

Hello all. Hope you're doing well this week. I have a matter that I need your reply to as soon as possible.

Pastor Jeff Mueller at Restore Church in Yankton contacted me recently about releasing any claim that the DBC has on the parsonage of the former Yankton Baptist Church (YBC). Recently the church building and parsonage belonging to YBC was given to Restore Church, which is a DBC church. The church building will be used by Restore, but the understanding between YBC and Restore was that the parsonage would be sold. They have a buyer. The parsonage is in a different part of the city from the church building.

When the title search was done it was discovered that the DBC is listed on the deed of the parsonage. The attorney that Restore is using called me asking that we release our interest in the property by granting it to Restore Church through a quit claim deed. This action will enable them to sell the parsonage to the buyer. He has subsequently sent me a deed to sign on behalf of the DBC.

As a Convention I can see no need to retain any claim to this house. It is distinct from the church building and our signing of the quit claim deed will have no impact on that building. Jeff told me that no changes were made to the church building deed. It was simply conveyed from YBC to Restore Church. I don't know whether it contained a reversion clause, but if it did, it still does.

I am requesting that the Board authorize me to sign the quit claim deed on behalf of the DBC. The effect of this action would be to release any claim that the DBC has on the parsonage property.

I would normally wait for our Board meeting in August, but since time is of the essence, I am asking that you grant this authority via e-mail. Please reply back with either YES, if you agree to release the property and NO, if you do not. If you have questions or comments, please reply back with those, as well. Please reply back by noon on Thursday, July 23.

Admin Team recommendation for 2021 budget (included in Executive Board Notebook)

Administrative team asks we approve the 2021 proposed budget with the following changes and explanations:

- 1. Executive Director travel change from \$18,000 to \$15,000
- 2. Church growth leadership development and evangelism from \$10,000 to \$6000
- 3. Church Relation Missionaries change from \$24,000 to \$36,000
- 4. Church Relation Missionaries travel and expenses change from \$6000 to \$9000
- 5. CP giving by the convention of 29% be changed to 25% for 2021 and any giving over \$420,000 CP giving would be 50%
- Executive Board meetings be changed to two in-person and 1 Zoom meeting. (Zoom meeting would be the March scheduled meeting.) This would decrease our budget line item from \$7000 to \$4500
- 7. Employee Retirement reduce from 10% of salary and housing to 6% plus match up to an additional 2% match from employee contribution.

- Move DBC office from current location to a DBC church. Would lower line item from \$20,530 to \$10,000. (if we stayed at our location, we would need \$23,000 for 2021 budget.
- 9. Evangelism added under line item 53020 Evangelism Church Strengthening and Leadership Development would all be changed from \$10,000 to \$6000

Discussion. NOTE: Deductions to Executive Director line items were recommended to the Administrative Team by Fred MacDonald. Approved

Administrative Team proposed calendar for 2021 – included in packet. With the following changes:

- March 12 Executive Board meeting will be on Zoom Admin team will meet at 10AM CST and board will meet from 1PM CST to 5PM CST
- 2. Youth Camp no dates suggested yet. Date to be determined by the Gathering
- 3. Executive Board August meeting August 6 & 7 in Pierre.

Discussion. Approved.

Administrative Team recommends the following for Christmas Bonuses. Last year we gave 1% of salary to salaried staff. \$250 to part time / \$500 to full time NAMB staff and DBC hourly staff. At this point the Administration Team will be postponing the recommendation until clarification of which line item the bonuses will be paid from can be made, and we will be emailing the board for further recommendations and approval (see Addendum).

Administrative Team recommends the following regarding Jeff Musgrave transition from the DBC to another role.

- 1. We allow Jeff to keep his car, laptop and printer that are DBC equipment.
- 2. If Jeff is not able to find insurance for his family, that the DBC would provide health insurance for them through March 31, 2021. # Dakota Baptist Convention Articles of Incorporation and Constitution Approved September 21, 2017

#### ARTICLE I - NAME

The name of this Corporation is and shall be the "Dakota Baptist Convention, Inc." (Convention).

#### ARTICLE II - DURATION

The term of this Corporation shall be perpetual, unless sooner dissolved.

#### ARTICLE III - PURPOSE

SECTION 1. The purpose of this Corporation (Convention) shall be to furnish a medium of cooperation for member churches in North and South Dakota in their divinely commissioned work of missions, evangelism, education, and benevolence in keeping with the strategy adopted by the Executive Board. This Convention is an autonomous body made up of messengers from cooperating Baptist churches in Annual Session. This Convention shall not exercise authority over any church but shall always recognize and hold inviolable the autonomy of each local church under the Lordship of Christ.

**SECTION 2.** The enumerated purposes and powers of the Convention shall not proscribe or abridge the exercise of any other right or power which the Convention might now or hereafter be permitted or required to exercise by law, provided always that such powers shall be exercised for the benefit of member churches of the Convention consistent with the purpose and mission of the Convention.

**SECTION 3**. This Convention is a non-profit Corporation, organized and operating exclusively for religious purposes. As such, no part of the revenues of this Convention may inure to the benefit of any individual. The assets of the Corporation are exclusively and irrevocably dedicated to and for religious purposes. As such, no assets of the Convention may be used for or inure to the benefit of any individual.

#### ARTICLE IV - MEMBERSHIP

- **SECTION 1.** The membership of this Convention shall consist of messengers to the Annual Meeting or a called meeting of the Convention, duly elected by legally constituted cooperating (member) churches.
  - 1(a) A local church affiliates with the Dakota Baptist Convention (1) by affirming the current Baptist Faith and Message by vote of the church and written notification to the Dakota Baptist Convention, (2) by contributing to the Dakota Baptist Convention Cooperative Program a minimum of \$500.00 per calendar year, and (3) by submitting an Annual Report (the Annual Church Profile, ACP) to the Convention.
  - 1(b) Churches wishing to affiliate shall be put on probationary status upon affirmation of the current *Baptist Faith and Message*. Churches shall be eligible for full membership in the Convention after meeting the requirement for Cooperative Program giving and submission of an Annual Report (ACP) to the Convention. Probationary status for a church or church plant is

removed when the church has met all requirements and is approved by the Executive Board of the Convention.

SECTION 2. Each cooperating (member) church electing messengers to the Convention in session is allowed three (3) messengers. Churches are allowed an additional messenger for each additional fifty (50) resident members or fraction thereof over the first fifty (50). A church may add an additional messenger for each \$500 in Cooperative Program contributions to the Convention during the report period of the Annual Report. However, no church may seat more than ten (10) messengers to the Convention in session. Any church plant, church-type mission, or church that is either (1) not legally constituted or is (2) in probationary status shall be entitled to one (1) messenger to the Convention in session.

SECTION 3. The basis for determining resident membership and Cooperative Program contributions shall be the Annual Report (ACP) submitted to the Convention in the same calendar year as the Convention in session. If the Convention in session occurs so that there is inadequate time to review that year's Annual Report, the previous year's Annual Report may be used at the discretion of the Credentials Committee.

SECTION 4. Churches wishing to seat messengers at the Convention in session must show that they have contributed at least \$500.00 to the Dakota Baptist Convention Cooperative Program within the previous twelve (12) months, have submitted an ACP for the previous year, and have submitted the names of elected messengers to the Credentials Committee of the Convention before the opening of the Convention in session. Churches which do not meet the criteria for seating messengers may appeal to the Credentials Committee. Any such appeal must be submitted to the Credentials Committee Chairman before the opening day of the Convention in session. The Credentials Committee will evaluate the request to seat messengers on a case-by-case basis, guided by the current Baptist Faith and Message and information provided by the church, even if no Annual Report (ACP) is submitted for that calendar year. The Credentials Committee may recommend seating messengers from a church they consider to be genuinely in sympathy with the work and purposes of the Convention.

#### ARTICLE V - NONPROFIT CORPORATION

The Dakota Baptist Convention is a non-profit Corporation organized under the laws of South Dakota. As such, the Corporation shall not have capital stock, and no dividends or pecuniary benefits shall be declared or paid to any member thereof. The Corporation shall neither have nor exercise any power, nor engage directly or indirectly in any activity that would invalidate its status as a non-profit Corporation under South Dakota law, or as a tax-exempt organization under Section 501{c}(3) of the Internal Revenue code of 1986, as amended, or the corresponding provision or provisions of any subsequent United States Internal Revenue law or laws.

#### ARTICLE VI - CORPORATE OFFICE AND AGENT

The address of the Convention's Registered Office is P. O. Box 549, 1604 Mountain View Road, Suite 1, Rapid City, South Dakota 57709. The Registered Agent at such address is the Executive Director-Treasurer of the Dakota Baptist Convention, Garvon Golden, or his successor.

#### ARTICLE VII - OFFICERS

- **SECTION 1.** The officers of the Convention shall be a President, Vice President, Recording Secretary, Assistant Recording Secretary, and such other officers as the Convention may determine.
- SECTION 2. The officers of the Convention shall be elected annually by a majority vote of the messengers present and voting at the Annual Meeting of the Convention. Elected officers shall take office at the close of the Annual Meeting and hold office until their successors are elected and installed.
- **SECTION 3.** The Executive Director-Treasurer shall serve as the Chief Executive Officer and Treasurer of the Convention and serve as an *ex-officio* member with vote of all Convention and Executive Board committees. Other employees of the Convention, its boards, or agencies shall not be eligible for election to any office.

#### ARTICLE VIII - EXECUTIVE BOARD

The Convention shall elect an Executive Board in keeping with provisions of the Bylaws of the Convention (Art. VII). The Executive Board shall serve as the Convention *ad interim* and as principal advisory body to the Convention.

#### ARTICLE IX - AGENCIES

- **SECTION 1.** The Convention may establish agencies to accomplish its mission. All agency board members shall be members of cooperating Dakota Baptist Convention churches.
- SECTION 2. The Convention in Annual Session shall approve or amend the articles of incorporation of an agency by two-thirds vote, provided that no amendment may be considered after the second session of the Annual Meeting. Any proposed articles or amendments must be submitted in writing to the Convention office at least one hundred twenty (120) days prior to the Annual Meeting, and notice must be published in the state Baptist paper or mailed to the churches at least ninety (90) days prior to the Annual Meeting.
- SECTION 3. Members of an agency's board of directors shall be elected by the Convention for three-year terms, with one-third of the directors elected each year. Directors shall be nominated by the Nominations Committee in consultation with that agency's then current board of directors. The Nominations Committee's recommendations shall be forwarded to the Convention office one hundred twenty (120) days prior to the Annual Meeting. The number of directors, their qualifications, and responsibilities, shall be stipulated in the agency's articles of incorporation and bylaws.
- **SECTION 4.** If a vacancy occurs on any agency board of directors, the Executive Board may elect a qualified person to serve until the next Annual Meeting, such person being recommended by the Nominations Committee. In no case may a vacancy continue for longer than six (6) months or until the next annual meeting, whichever occurs first. The Convention shall fill the unexpired term of a director at its next regular Annual Meeting.
- SECTION 5. An agency's board of directors in whole or in part may be replaced by a vote of the Convention in session or by a two-thirds vote of the Executive Board acting *ad interim*. Grounds for

replacement include misfeasance, incapacity, failure to perform assigned duties, or any conduct which would bring discredit upon the agency or the Convention.

**SECTION 6.** The Convention shall exercise oversight of all agencies through the respective boards of directors. Management responsibility for each agency shall be assumed by its own board of directors (trustees). The board of directors of each agency shall hold title to properties, real and personal, ensure fiscal integrity of the agency, employ agency personnel, make contracts on behalf of the agency, and conduct long range planning to achieve the objectives and accomplish the mission of the agency.

**SECTION 7.** Each agency shall report to the Convention in the Annual Meeting. This report shall include financial reports, projected budgets, progress on program objectives in light of long-range plans, and other information as requested by the Convention or its Executive Director.

#### ARTICLE X - COMMITTEES

The committees of the Convention shall be a Constitution Committee, Credentials Committee, Resolutions Committee, Nominations Committee, Program Committee, and such other committees as may be deemed necessary to carry out the work of the Convention. Members of committees shall be elected by the Convention and must be members of cooperating Convention churches. The assignment of each committee shall be established in the Articles of Incorporation and Constitution, and the Bylaws of the Convention.

#### ARTICLE XI - MEETINGS

- **SECTION 1.** The Convention shall meet once each year for an Annual Meeting. The time and place for the Annual Meeting shall be approved by the Convention, upon recommendation of the Program Committee.
- **SECTION 2.** In an emergency, the President of the Convention, in consultation with the Executive Board, may change the time and/or place of the Annual Meeting.
- SECTION 3. In an emergency, the President of the Convention, in consultation with the Executive Board, may call a special meeting of the Convention. See Bylaws, II.4

#### ARTICLE XII - CONTRIBUTIONS AND FUNDS

- **SECTION 1.** The Cooperative Program shall be the chief means of financial support for all Convention programs and missionary endeavors.
- **SECTION 2.** All funds of this Convention shall be raised by voluntary contributions. However, the Convention may acquire property by bequest, or make use of any bequest, including use of any income producing assets.
- **SECTION 3.** All designated gifts accepted by this Convention shall be used strictly according to the expressed will and direction of the donor.
- **SECTION 4.** Neither this Convention, nor any institution or agency owned or supported in whole or in part by this Convention, shall accept or receive any funds, gifts, grants, or other monies or assets

from any government source (Federal or state) without the written approval of the agency's board. Any such funds received must be reported in full to the Convention's Executive Board.

#### ARTICLE XIII - INDEMNIFICATION

The Dakota Baptist Convention, and its agencies, institutions, and boards, shall indemnify any director (trustee) or officer, or former director or officer of the Corporation, and their respective heirs, administrators, successors, and assigns, against any and all expenses, including amounts paid upon judgments, counsel fees, and amounts paid in settlement (before or after suit is commenced), actually and reasonably incurred by such persons in connection with the defense or settlement of any claim, action, suit or proceeding in which they, or any of them, are made parties, or a party, or which may be asserted against them or any of them, by reason of having been trustees or officers or a trustee or officer of the Corporation; provided, however, that such indemnity should not be operative with respect to (1) any matter as to which such person shall have been adjudged in such action, suit, or proceeding to be liable for negligence or misconduct in the performance of his duties as such trustee, officer, or employee, or (2) any matter settled or compromised, unless, in the opinion of independent counsel selected by or in a manner determined by the trustees, there is not reasonable ground for such person's being adjudged liable for negligence or misconduct in the performance of his duties as such trustees or officer.

#### ARTICLE XIV - AMENDMENTS

Amendments may be made to this Constitution/Articles by a two-thirds vote of the members (messengers) present and voting at any Annual Meeting of the Convention, provided that (1) no amendment may be considered after the second session of the Convention and that (2) the proposed change is submitted in writing to the Convention office and the Executive Board at least one hundred twenty (120) days prior to the Annual Session and published in the state Baptist paper or mailed to the churches at least ninety (90) days prior to the Annual Session.

#### ARTICLE XV - DISSOLUTION

Section 1. In the event of the dissolution of the Corporation (Convention), all of its property, whether real, personal, or fixed, of whatsoever nature and wheresoever situated, shall be vested in the cooperating churches or their legal successors. The Corporation shall have authority through the Executive Board to liquidate any and all assets in such manner as they deem advisable and advantageous and to donate any proceeds to the North American Mission Board of the Southern Baptist Convention for work in the Dakotas.

**Section 2.** Assets held by the Corporation that are subject to conditions requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements.

**Section 3.** Under no condition or circumstances shall any member or members, director or directors, officer or officers, or any other persons connected with this Corporation share in the proceeds of such liquidation.

#### ARTICLE XVI - PROPERTY

The terms and conditions under which conveyances or encumbrances of all or any part of the corporate property may be made shall be authorized in keeping with the provisions of the Articles of Incorporation and Constitution and the Bylaws of the Convention.

#### ARTICLE XVII - INDEBTEDNESS

- Section 1. All borrowing by this Convention for its own use, or for any agency or institution, or borrowing by any institution or agency, which directly or indirectly obligates this Convention, the payment of which would require an extension of time beyond the close of the subsequent fiscal year, shall be authorized only on the following terms and conditions:
  - **1(a)** The Executive Board shall have authority to borrow funds in anticipation of current revenue, provided that any unpaid balance of such borrowing at the end of the current fiscal year shall be included in the budget for the subsequent fiscal year.
  - **1(b)** No institution or agency of this Convention shall encumber its real property or change its status with respect to this Convention without authority from this Convention.
  - **1(c)** Institutions and agencies of this Convention shall have authority to borrow money in anticipation of current revenue, provided that any unpaid balance of such borrowing at the end of the current fiscal year shall be included in the budget for the subsequent fiscal year.

Section 2. Any anticipated borrowing of funds other than those stipulated in the foregoing sub-section must be approved by a two-thirds vote of the Convention in session, upon recommendation of the Executive Board.

#### ARTICLE XVIII - AUTHORITY AND SUPERSESSION

These Articles of Incorporation and Constitution fully set forth the provisions of the Articles of Incorporation of the Dakota Baptist Convention as amended. They have been adopted as required by law, and they supersede the original Articles of Incorporation and all amendments.

## Dakota Baptist Convention Bylaws Adopted September 21, 2017

#### ARTICLE I - MESSENGERS

- **SECTION 1.** Each member church shall present to the Credentials Committee of the Dakota Baptist Convention a list of its elected messengers, in keeping with the Articles of Incorporation and Constitution, Article IV.
- **SECTION 2.** Each messenger shall register with the Credentials Committee prior to being seated as a messenger to the Dakota Baptist Convention.
- SECTION 3. The Credentials Committee shall review the credentials of registered messengers and make its report to the Dakota Baptist Convention in the first business session of the Annual Meeting.

#### ARTICLE II - MEETINGS

- **SECTION 1.** The Dakota Baptist Convention shall meet each year for the purpose of worship, inspiration, electing officers, receiving reports of officers, committees, and boards, and for conducting necessary business.
- SECTION 2. The latest edition of *Robert's Rules of Order, Newly Revised* shall be recognized as the standard authority on questions of parliamentary procedure for the Dakota Baptist Convention.
- **SECTION 3.** A quorum for any session of any meeting of the Dakota Baptist Convention shall be defined as the messengers present and voting in that session.
- **SECTION 4.** The Dakota Baptist Convention shall approve its order of business at the first session of the Annual Meeting.
- SECTION 5. Special sessions of the Dakota Baptist Convention may be scheduled as follows: (1) The President, in consultation with the Executive Board, may call the Dakota Baptist Convention into special session as necessary, (2) The Dakota Baptist Convention in session can call for a special session by a majority vote.
- **SECTION 6.** The minutes of the Annual Meeting shall be received by the Executive Board at its first meeting following the Annual Meeting.

#### ARTICLE III - OFFICERS

SECTION 1. The recording secretary and assistant recording secretary will be nominated to the Convention by the Nominating Committee. The officers of the Dakota Baptist Convention shall be President, Vice President, Recording Secretary and Assistant Recording Secretary. The office of Treasurer shall be filled by the Executive Director-Treasurer of the Dakota Baptist Convention for an indefinite term.

- SECTION 2. The President and Vice President shall be elected annually from messengers in attendance at the Annual Meeting. Officers shall be members of cooperating Dakota Baptist Convention churches. Nominations shall be from the floor. Election shall be by ballot except when there is a single nominee for an office, in which case the President shall instruct the Secretary to cast a unanimous ballot for the nominee. The Recording Secretary and Assistant Recording Secretary shall be nominated by the Nominations Committee and elected by messengers at the Annual Meeting. They shall be members of cooperating Baptist churches.
- SECTION 3. Employees of the Dakota Baptist Convention, its boards and agencies are not eligible to serve as elected officers of the Dakota Baptist Convention, with the exception of the Executive Director-Treasurer, who serves an indefinite term as Treasurer.
- SECTION 4. Officers shall serve for one (1) year and hold office until their successors are elected and installed; however, no officer may serve more than two (2) complete successive terms in the same office except the Recording Secretary and Assistant Recording Secretary. Terms of office shall commence at the adjournment of the Dakota Baptist Convention in session at the time of their election and terminate at the adjournment of the succeeding Annual Session of the Dakota Baptist Convention. In case of death, disability, or other cause preventing continued service by the President, the Vice President, then the Recording Secretary, shall succeed in order. The Executive Board shall have responsibility for declaring an office vacant.
- SECTION 5. The President shall preside over all meetings of the Dakota Baptist Convention and shall perform such other duties as specified by the Constitution/Articles of Incorporation and Bylaws of the Dakota Baptist Convention. The President shall be a voting *ex officio* member of all Dakota Baptist Convention committees and boards. The President is authorized to appoint the Vice President to serve as *ex officio* member with vote of any committee or board in his/her absence.
- SECTION 6. In the absence of the President or when requested by the President, the Vice President may preside over meetings of the Dakota Baptist Convention, and shall perform other duties as specified in the Constitution/Articles of Incorporation and Bylaws of the Dakota Baptist Convention, or as may be requested by the President. The Vice President shall serve as a voting *ex officio* member of the Executive Board of the Dakota Baptist Convention.
- SECTION 7. The Recording Secretary shall produce accurate and timely minutes of all sessions of the Dakota Baptist Convention. A summary of minutes shall be filed at the Convention office, published, and sent to all cooperating churches in the Convention together with such other information as the Dakota Baptist Convention or the Executive Board deems necessary and proper. The Assistant Recording Secretary will assist in these duties. The office of the Executive Director-Treasurer may provide assistance as needed.
- **SECTION 8.** The presiding officer of a Convention session may appoint a parliamentarian to assist if the presiding officer deems it necessary or helpful.

#### ARTICLE IV - EXECUTIVE DIRECTOR-TREASURER

**SECTION 1.** The Dakota Baptist Convention shall employ an Executive Director-Treasurer as its Chief Executive Officer and Treasurer. The Executive Director-Treasurer shall provide administrative

oversight, strategic leadership, and spiritual leadership for the total program of the Dakota Baptist Convention.

SECTION 2. When a vacancy occurs in the office of Executive Director-Treasurer, the Administrative/Personnel committee of the Executive Board of the Convention shall conduct a search and shall recommend a candidate for the position to the Executive Board. A two-thirds vote of the Executive Board is necessary to elect a candidate. With permission of the candidate, the Executive Board shall release biographical data to the churches of the Dakota Baptist Convention. The Executive Board may select an Interim Executive Director-Treasurer to serve until the Executive Board elects a successor.

SECTION 3. The Administrative/Personnel Committee shall be responsible for maintaining an up to date job description for the position of Executive Director-Treasurer. The job description shall be approved by the Executive Board of the Convention and reviewed on an annual basis.

**SECTION 4.** The Dakota Baptist Convention in session may terminate the Executive Director-Treasurer by majority vote. The Executive Board may terminate the Executive Director-Treasurer by two-thirds vote of the elected members.

#### ARTICLE V - COOPERATING CHURCH OR CHURCH TYPE MISSION

A cooperating church or church plant shall be defined as follows: (1) The church has affirmed the current *Baptist Faith and Message* by a vote of its body, and confirmed that vote in writing to the Convention; (2) A cooperating church contributes regularly (quarterly or monthly) to the Cooperative Program and contributes a total of at least \$500 each year; (3) A cooperating church reports yearly through an Annual Report (Annual Church Profile; ACP). Churches failing to contribute to the Cooperative Program for a twelve (12) month period, or failing to submit an Annual Church Profile, or failing to affirm the current *Baptist Faith and Message* will be deemed non-cooperating.

#### ARTICLE VI - DAKOTA BAPTIST CONVENTION COMMITTEES

#### SECTION 1. STANDING COMMITTEES

The President of the Dakota Baptist Convention shall nominate the Standing Committees, including their chairmen, for election by the Dakota Baptist Convention in session. Members of Standing Committees shall serve a two-year term. Each Committee will elect its own Secretary. The Committees will schedule meetings as needed but are encouraged to utilize time during or near the Annual Meeting of the Convention. Each Committee should review its work in consultation with the Dakota Baptist Convention President and Executive Director-Treasurer. The Standing Committees are as follows:

- 1(a) Constitution and Bylaws. The principle duty of the Committee is to review the Constitution and Articles of Incorporation and Bylaws of the Dakota Baptist Convention and the bylaws of its agencies, and to recommend changes as appropriate. The Committee shall present any recommendations to the President and Executive Director-Treasurer 120 days before the Annual Meeting and publish the recommendations in the state Baptist paper or mail to the churches 90 days before the Annual Meeting.
- **1(b)** Nominations Committee. The Committee is responsible for recommending members for the Executive Board of the Dakota Baptist Convention and members of the boards of directors

of the Convention agencies in keeping with Constitution/Articles of Incorporation and Bylaws of the Dakota Baptist Convention. A diversity of committee nominees is desired, e.g., in terms of gender, ethnicity, vocation, geography, churches, and associations. It is expected that each nominee will act in the best interests of the Dakota Baptist Convention work as a whole. The Nominations Committee shall submit a full report to the Executive Director-Treasurer of the Dakota Baptist Convention 90 days before the Annual Meeting, for inclusion in the annual *Book of Reports*.

#### SECTION 2. ANNUAL COMMITTEES

Annual Committees are the Annual Session/Program Committee, Credentials Committee and Resolutions Committee. The Credentials Committee and Resolutions Committee shall be appointed by the President of the Dakota Baptist Convention within thirty (30) days following the close of the Annual Meeting. The Annual Session/Program Committee shall consist of individuals determined by the positions they serve. Members of Annual Committees will serve a term of two (2) years.

- 2(a) Annual Session/Program Committee. The Program Committee shall consist of the President, Vice President, the Executive Director-Treasurer, staff of the Dakota Baptist Convention, and a representative of the host association. The Committee is primarily responsible for planning the program and future sites for the Annual Meeting. The Committee will also assist in enlisting program personnel, assist the President in amending the order of business during the Annual Meeting, and assist with other related matters as requested by the President or Executive Director-Treasurer of the Convention. The Committee is responsible for recommending a site for the Annual Meeting of the Convention, considering the need to rotate sites throughout the Dakotas, and the availability of adequate meeting space and adequate hotel/motel rooms. The Executive Board will recommend to the Committee times and dates for the Annual Meeting two to five years in advance.
- 2(b) <u>Credentials Committee</u>. The Credentials Committee is responsible for certifying messengers from churches for meetings of the Dakota Baptist Convention. The Committee will provide messengers with badges, ballots, and other materials for the execution of their duties as messengers. The Committee will assist the President in all balloting processes, certify votes and elections, and assist in related matters as requested by the President or Executive Director-Treasurer of the Convention.
- **2(c)** Resolutions Committee. The Resolutions Committee shall review all properly submitted resolutions and shall present resolutions to the Convention for consideration. All proposed resolutions to the Dakota Baptist Convention are to be submitted in writing 30 days in advance of the Annual Meeting. The Committee may edit resolutions for clarity, combine like issues into one resolution, or reject resolutions deemed redundant, obsolete, or inappropriate. The Resolutions Committee shall ask for proposed resolutions to be submitted prior to 30 days before the Annual Meeting.

#### ARTICLE VII - EXECUTIVE BOARD

SECTION 1. Organization. The Executive Board shall organize itself and elect its officers upon the adjournment of the Annual Meeting. The officers of the Board shall be elected by the Board and shall consist of a Chairman and Vice Chairman. The Chairman may serve as Chairman for no more than three

- (3) years. The Recording Secretary and Assistant Recording Secretary shall serve as secretaries for the Executive Board but shall not be considered members of the Board.
- SECTION 2. Number of Members and Terms. The Executive Board shall be composed of no more than twelve (12) elected members and three (3) ex-officio members with vote, viz., the Executive Director-Treasurer, President, and Vice President of the Convention. Upon the recommendation of the Executive Board, the Convention in Annual Session can increase the number of Board members as needed. Executive Board members shall be elected for three-year terms. After the first three-year term a member may be elected for a second three-year term. After serving a second three-year term the member must rotate off the Board for at least one (1) year before being eligible to serve again. When a person fills an unexpired term of a member, that person can serve the rest of that term and can be eligible to serve another three-year term as long as both do not exceed six (6) years.
- SECTION 3. Administrative/Personnel Committee. The Executive Board shall establish an Administrative/Personnel Committee, which shall meet as necessary between sessions of the Executive Board. The Administrative/Personnel Committee shall perform duties as assigned to it by the Executive Board. The Administrative/Personnel Committee shall be composed of the Executive Board Chairman and Vice Chairman, one Executive Board member at-large, and the President, the Vice President, and Executive Director-Treasurer of the Convention. The specific duties of the Committee are to act between sessions of the Executive Board as assigned, monitor and recommend changes to policies of the Dakota Baptist Convention, help prepare the Board agenda, recommend the Executive Board organization and temporary work groups, supervise the Executive Director-Treasurer on behalf of the Board, serve as the search committee for an Executive Director-Treasurer when a vacancy occurs, consult with the Executive Director-Treasurer on recommendations for prospective staff personnel, and work with the Executive Director-Treasurer and Convention staff in developing and implementing long range strategic plans.
- SECTION 4. Responsibilities. The Executive Board is to serve as the Dakota Baptist Convention ad interim and as the principal advisory body to the Convention. The Executive Board shall not contravene actions or policies of the Dakota Baptist Convention. Specific responsibilities of the Executive Board are as follows:
  - **4(a)** Serve as the operating board for all Convention programs not assigned to other boards or agencies.
  - **4(b)** Evaluate the performance of the Executive Director-Treasurer of the Dakota Baptist Convention, and assist him in the exercise of his responsibilities for program and spiritual leadership as Chief Executive Officer of the Convention.
  - **4(c)** Act as agent of the Dakota Baptist Convention in all matters not assigned to Convention agencies, to include execution of any and all deeds, mortgages, deeds of trust, assignments, or other conveyances that the Executive Board may deem necessary to its legal and fiduciary responsibilities. The Dakota Baptist Convention herewith authorizes and directs the Chairman of the Executive Board and its Executive Director-Treasurer to execute all such aforementioned documents on behalf of the Dakota Baptist Convention.
  - **4(d)** All gifts of money other than the general budget of the Dakota Baptist Convention or other property made to the corporation shall be disbursed according to the donor's designation. The

corporation shall have the power at all time to accept or reject designated gifts. Undesignated gifts shall be distributed in accordance with the corporation's budget.

- **4(e)** Act upon recommendations of the Nominations Committee to fill any vacancies occurring between Annual Meetings.
- **4(f)** Provide oversight of and ensure adequate arrangements for all Dakota Baptist Convention sessions.
- **4(g)** Recommend a proposed budget to the Convention for each fiscal year. The proposed budget shall be published and distributed to all the churches of the Dakota Baptist Convention at least thirty (30) days prior to consideration and vote by the Convention in its Annual Session.
- **4(h)** Establish and revise policies relating to the duties of the Executive Board and maintain policy manuals. The Executive Board shall work closely with the Executive Director-Treasurer to ensure an organization that is both functional and accountable. Policy manuals are subject to review and may be amended by a simple majority vote of the Executive Board.
- **4(i)** Provide oversight for long range planning of the Dakota Baptist Convention and coordinate the long-range planning of any agency board with the long-range plan of the Convention.
- **4(j)** Ensure a regularly scheduled audit (at least every two years) of the Dakota Baptist Convention's financial records, publish financial reports in the *Book of Reports* at each Annual Session, and oversee the management of all Convention accounts.
- **4(k)** Approve and employ Board approved staff personnel upon recommendation of the Executive Director-Treasurer and the Administrative/Personnel Committee. The Executive Board shall approve personnel policies.

#### SECTION 5. Meetings.

- **5(a)** The Executive Board shall meet at least three (3) times each year on dates suggested by the Executive Director-Treasurer and approved by the Executive Board, and at additional times as determined by the Board. The organizational meeting of the Executive Board shall be held following the Annual Meeting.
- **5(b)** Members are expected to attend all Executive Board committee meetings and plenary sessions. Failure to do so may result in removal by the Dakota Baptist Convention in session. Each member is responsible for notifying the Chairman of the Executive Board or the Dakota Baptist Convention office in any case necessitating an absence.
- **5(c)** The Executive Board may be called into special session by the Administrative/Personnel Committee.
- 5(d) A majority of the Executive Board shall be considered a quorum for any Board meeting.

#### SECTION 6. Reports.

- **6(a)** The Executive Board shall prepare and publish a comprehensive report of the work of the Dakota Baptist Convention and a summary of actions taken by the Executive Board in the annual Book of Reports.
- **6(b)** The Executive Board shall publish a summary of Executive Board actions in the state Baptist paper after each session.

#### ARTICLE VIII - AMENDMENTS

Amendments may be made to these Bylaws by a simple majority of the messengers present and voting at any Annual Meeting of the Convention, provided that (1) no amendment may be considered after the second session of the Convention and that (2) the proposed change is submitted in writing to the Convention office and the Constitution and Bylaws Committee at least one hundred twenty (120) days prior to the Annual Meeting and published in the state Baptist paper or mailed to the churches ninety (90) days prior to the Annual Meeting.

#### State Staff Reports

#### **Executive Director Report**

What an incredible year we have faced! With everything from a pandemic to civil unrest to financial despair, it would be easy for some to wonder, "Is there anything left in which to have hope?" We preacher-types have declared for years, "When Jesus is all you have, you have all you need!" 2020 has given us opportunity to discover whether we really believe that, or if that was just another spiritual bromide intended to soothe our congregations.

Let me declare with absolute certainty and conviction, our God reigns. In the midst of a world that seems to be spinning out of control, He is on His throne and His Kingdom continues marching forward. It is exciting to know He calls us to join Him in bringing His message of peace, reconciliation, and salvation to those who have abandoned all hope. It is undeniably true, "When Jesus is all you have, you have all you need!

It is an honor to make my first report to you as your Executive Director. As I look to the horizon of what lies ahead for Dakota Baptists, I have never been more filled with hope and excitement. I have never felt a greater desire to celebrate God's goodness. And we have many reasons to celebrate.

#### Celebration #1: Visions realized

Having grown up in the Dakotas, I have vivid memories of leaders past standing before annual meetings and expressing their vision and hope that one day we would be one of those conventions that stood on their own two feet. One that was reaching out to others more than having others reach out toward us. Yes, I really did enjoy going to denominational meetings as a teenager! I'm not sure what that says about me.

Most recently this heart's desire was expressed in the 2020 vision, which was adopted seven years ago. It laid out three stewardship goals to achieve by 2020: 1) increase Cooperative Program giving from DBC churches to \$400,000, 2) increase Cooperative Program giving that is sent to worldwide mission causes to 20%, and 3) move from a 95/5 funding ratio with NAMB to an 80/20 ratio.

All three of these goals were accomplished under the leadership of my predecessor Garvon Golden. I give thanks to God for him and for his faithful stewardship and vision. Thank you Garvon and Cindy for your faithfulness to Jesus and for your years of friendship and fellowship.

Would you like even more reason to celebrate visions realized? In the budget that you will consider at this year's Gathering, you will notice that we are taking a large leap towards another milestone, one that will be fully realized in the 2022 budget. Ninety-five percent of the 2021 general budget will be paid for through DBC sources. Only 5% of the budget will come from NAMB and none from LifeWay. And, guess what? The 2022 budget will be 100% Dakotafunded! . . . and all it took was a pandemic!!!

This will be the first time in the history of our Convention, dating back to our days as the Northern Plains Baptist Convention, that we will be able to make this claim. For the first time ever, the dreams that I heard from the heart of men like John Baker, Roy Owens, and Dewey Hickey will come to life through the churches of North and South Dakota.

While there are still struggles and while we will face more challenges in this time of economic uncertainty, this is a day to celebrate. We are standing on the shoulders of those who have made great sacrifice and we can now see the dawning of a day they only dreamed of. To God be the glory, great things He has done.

## Celebration #2: New visions for a new decade

As we enter a new decade and as we confront the knuckle balls 2020 has thrown at our world, we have a hard-working group that has been working for two years to lay out a plan to guide us. The State Staff Study Task Force was formed in 2018. They worked for about a year, paused during the time of transition after Garvon announced his retirement, then restarted and finished the work in April of this year.

While they could not have foreseen the realities we now face, God was guiding them in the early days of their work toward a strategy that would reshape our staff and prepare us for a day when our budget would need to be fully funded through our own CP giving. In fact, in a paradoxical way, the pandemic of 2020 made completing their work a much easier task.

They presented their report and proposal to the DBC Executive Board in August 2020 and the proposal was unanimously approved for implementation on January 1. I won't detail their work here, because they will have opportunity to do so during the Gathering and because I don't want to steal their blessing as they share some surprising things that they discovered in their research, present our new staff structure, and lead us to celebrate the victories these represent.

For now, let me simply say thank you to this group that gave of themselves to help chart a course for the next several years. Your efforts give you an important place in the legacy of Kingdom work that God has accomplished and will continue to accomplish through Dakota Baptists. And they give us great reason to celebrate.

## Celebration #3: Guiding principles for the road ahead

The final celebration I want to share is more personal. I could not have possibly imagined when I was baptized as a 16-year old boy by my pastor and mentor Wendell Mosser at the old Knollwood Baptist Church in Rapid City, that one day I would be given the honor of serving pastors, churches, and associations like the ones I grew up with and in. I think I understand what a newly crowned King David meant when he cried out to God, "Who am I, O Lord GOD, and what is my house that You have brought me this far" (2 Sam. 7:18).

The young king went on to declare with boldness, "And yet this was insignificant in Your eyes, O Lord GOD, for You have spoken also of the house of Your servant concerning the distant future" (v. 19). God laid out for David principles that would guide him throughout the years that he served God's people.

As I prepared for the transition from serving as a Director of Missions in southeastern New Mexico to becoming Executive Director for the Dakotas, God placed on my heart four guiding principles for my life and work as your servant:

<u>Guiding Principle #1</u>: Build relationships that foster: 1) unity among our churches and 2) encouragement and strengthening of our pastors and their wives.

Guiding Principle #2: Continue the process begun by the Board to shape the DBC future by: 1) staying focused on the mission of helping churches fulfill the Great Commission and Acts 1:8, 2) cultivating partnerships that enable us to accomplish the mission, and 3) striving to become a Convention that is decreasingly dependent, increasingly independent, but always reflecting cooperation because, "two are better than one" (Eccl. 4:9).

<u>Guiding Principle #3</u>: Recognize the special responsibility and opportunity God has given us to evangelize, equip, and mobilize the unreached, underreached, and often overlooked people groups in our midst.

Guiding Principle #4: Develop young Dakotans to reach Dakotans.

My plea to each of you is that you pray regularly for me and for Denise as we serve together with you. My commitment to you is that I will serve Jesus by serving you with integrity, transparency, and faithfulness to His Word.

And when the day comes that Dakota Baptists prepare once again to transition to a new leadership and new direction, I am confident that we will together with one voice be able to declare as Israel's new king did, "For this reason You are great, O Lord GOD; for there is none like You and there is no God besides You, according to all that we have heard with our ears" (2 Sam. 7:22).

# Church Health & Leadership Development Report

This year has brought us many challenges. Since last year's annual meeting and the extra time spent in Fargo for the snow days, The end of last year seems like a lifetime ago for me and probably for many of you as well. As we closed out the year, we were working to help our churches deal with the realities of sexual abuse and how we can be proactive to prepare well to prevent abuse in our churches. As this year has unfolded, I would encourage you to keep these safety systems in mind for the long term. Many of you took advantage of the Ministry Safe offer. We will continue to provide resources as they become available to help you in this area of safety for those we serve around the Dakotas. We had been doing roundtables to help highlight these resources back in March of this year, but I was unable to complete my roundtable visits in the spring because of circumstances beyond all of our imaginings.

While at the Executive Board meeting in March, I received a call that my dad was being moved to hospice after a couple of weeks in the hospital. I rushed to Arkansas and was able to be with my dad as he made his trip to go home to be with Jesus. We did this right as Covid was becoming a pressing part of everyone's lives and came back home to the Dakotas a couple of weeks later to a completely changed world, it seemed. I wanted to express my thanks to all of you for your prayers and caring for me and my family during this time. I appreciate the family we have here in the Dakotas more than words can express.

Upon returning home, I spent lots of time on the phone, since travel wasn't really an option. I offered help and assistance for those trying to navigate different aspects of doing services online and connected pastors to other pastors who had offered help for things like online streaming or online giving and looked to be a source of encouragement or a sounding board for frustrations as we all tried to navigate the changes week to week.

In May, I began to travel a little bit again. I did some pulpit supply and attended some of the round tables Fred hosted around the Dakotas. We also made the difficult decision that month to move youth camp to an online format for those who wanted to take part.

In June, we started the month with virtual camp. As I shared with many, it is something I am glad we had the ability to do and something I hope we never have the necessity to do again. We did have some good times of fellowship and learning and laughter and we feel there is some ideas to use from the experience for possible statewide youth events that can be done in a pod type of format with churches meeting locally and content being made available over a live stream.

Through the rest of the summer and into the fall, I did some pulpit supply and made visits to our interns in the field this summer. I began to work on transition plans for the last half of this year as the State Staff Task Force completed their work and offered their recommendations. I have also been able to participate and celebrate with churches doing ordinations and baptisms. Finally, we began laying the groundwork for the transitions to

come. As you may have seen in the reports, I am transitioning from full-time work with the staff to a church replanting role in Minot. We have seen God at work through these last few months as we prayed for direction in what comes next in ministry for me and our family. God is good and I thank those of you who have lifted us up with prayers and encouragement along the way.

I plan to continue working on expanding the DBMTI. Our Personal Evangelism and Discipleship course is now going, and we are planning to offer the final course for the first certificate program in the spring of 2021. After these classes are set up, we will be able to offer them more regularly when instructors are available to teach them. I am grateful to those who have been able to teach classes and would encourage others who are interested in teaching a class or taking classes to get in touch with me. In addition, I have added a basic help class for our online students designed to help them develop good learning strategies for online learning. I am working on a longer-term project to develop a ministry basics class and have been talking with TJ Green about developing a similar basics class on church revitalization. I believe this institute can be a helpful tool for us to develop leaders in the Dakotas for the long-term health of our churches and the leadership of new churches in the future.

As I transition into a new phase of ministry, I want to again say thank you to all of you who have encouraged, prayed, and partnered with me over these last six years as I have served on the DBC staff. I have been blessed beyond measure to get to know so many of you along the way and I look forward to the ministry we will have together in the days to come.

My family is at home in the Dakotas and we feel as though God still has work for us in the field where we are currently planted, so we are excited by the opportunity to help replant a church in Minot. We are trusting God and taking this process one day at a time with much prayer and counsel from friends in ministry. My goal is to finish strong in my current role and see the ways in which God will use me in the coming months and years in a new role. I plan to continue work with the DBMTI as a means to help us train leaders all around the Dakotas and in any other areas and ways God opens up for me to serve. Thank you all for your partnership in the Kingdom and for your prayers for me and my family.
