# Proposed Constitution Amendment Article X - Committees

The committees of the Convention shall be a Constitution <u>and Bylaws</u> Committee, Credentials Committee, Resolutions Committee, Nominations Committee, <u>Annual Session/Program Committee</u>, and such other committees as may be deemed necessary to carry out the work of the Convention. Members of committees shall be <u>selected by the Convention in accordance with the Bylaws of the Convention</u> and must be members of cooperating Convention churches. The assignment of each committee shall be established in the Articles of Incorporation and Constitution, and the Bylaws of the Convention.

# Proposed Bylaws Amendment Article VII - Executive Board

Section 2. Number of Members and Terms. The Executive Board shall be composed of no more than twelve (12) elected members and three (3) exofficio members with vote, viz., the Executive Director-Treasurer, President, and Vice President of the Convention. Upon the recommendation of the Executive Board, the Convention in Annual Session can increase the number of Board members as needed. Executive Board members shall be elected for three-year terms. After the first three-year term a member may be elected for a second three-year term. After serving a second three-year term the member must rotate off the Board for at least one (1) year before being eligible to serve again. When a person fills an unexpired first term of a member, that person can serve the rest of that term and can be eligible to serve another three-year term as long as both do not exceed six (6) years can be eligible to serve a second term. After serving this term, the member must rotate off the Board for at least one (1) year before being eligible to serve again. When a person fills an unexpired second term of a member, that person can serve the rest of that term and is eligible to serve two additional terms, after which the member must rotate off the Board for at least one (1) year before being eligible to serve again.

Last year, in my first report, I laid out four guiding principles that God placed on my heart as a guide for my work as your Executive Director for however long He allows me to serve Him by serving Dakota Baptists. They were:

- 1) Build relationships that foster: 1—unity among our Dakota churches and, 2—encouragement and the strengthening of our pastors and their wives
- 2) Continue the path to our future by: 1—staying focused on the mission of helping churches fulfill the Great Commission and Acts 1:8, 2—cultivating partnerships that enable us to accomplish the mission and, 3—striving to be a state convention that is decreasingly dependent, increasingly independent, but always reflecting cooperation
- 3) Evangelize, equip, and mobilize the unreached, underreached, and overlooked people groups in our midst
- 4) Develop young Dakotans to reach Dakotans

Last March the Executive Board created a task force to look ahead at our work as a convention over the next few years. Their task was to develop a plan to guide our cooperative efforts.

Starting with the four guiding principles as a foundation, the Dakota 2025 Vision Task Force, led by our DBC president Paul Young developed a new ministry plan that identified five biblical values that we treasure (who we are), a mission statement (why we are here), a vision statement (where we are headed), and thirteen objectives (how we will get there). The objectives were built around three key words from the mission statement: partner, strengthen, and start.

Your DBC staff then developed several actions for each objective for us to engage in over the next few years that will help us accomplish our mission. At their August meeting, the Board approved the plan for implementation. The task force will make a presentation at the annual meeting to unveil and launch our new ministry plan.

I am excited about what God is going to do in, through, and around Dakota Baptists as we move forward as a: "network of Great Commission churches that PARTNER together to STRENGTHEN established churches and START new churches.

I would like to express great appreciation to the team: Paul Young, Kristy Wallace, Jon Ballard, Steve Osage, Steve Ford, Sam Ellyson, and Stephen Carson. Your hard work and vision have laid a path for us to follow as we cooperate together across the Dakotas.

## A new (and historic!!!) budget

In another action at their August meeting, your Executive Board approved a 2022 budget of \$482,924. You will have opportunity at the annual meeting to discuss and vote on this budget.

There are two new things I want to highlight about our 2022 budget. The first is a new role for the Baker State Mission Offering. The second is a new step in our growth as a state convention.

1: A new role for our state mission offering: If the budget is approved, the Baker offering will become budget-based rather than allocation-based, beginning in 2022. What this means is that the annual state mission offering will be part of the regular income for the general budget, rather than being focused on specific designated ministry activity.

Beginning in January the administrative support that had been provided by NAMB and in past years by Lifeway, will be gone forever. Changing the focus of our state mission offering will replace the support that has come from outside the Dakotas for our operational budget with mission giving from our Dakota Baptist churches. In other words, we will be standing on our own two feet!

By the way, this will make our state mission offering more like NAMB's Annie Armstrong Easter Offering and the IMB's Lottie Moon Christmas Offering. Our two Southern Baptist mission agencies each receive a significant part of their annual budgets from these critical special mission offerings.

2: A new step in our growth as a state convention: The second thing I want to highlight about our budget is that this is a historic moment. Ever since our birth as the Northern Plains Baptist Convention, throughout our days as the Dakota Southern Baptist Fellowship, and more recently as the Dakota Baptist Convention, a significant part of our operational budget has always come from outside sources, most notably, the North American Mission Board and Lifeway. As I shared above, beginning January 1, these funds are gone permanently. With the adoption of the 2022 budget, for the first time in our history, our operational budget will be 100% funded by Dakota-based sources. This is a moment to pause and celebrate!!! Feel free to raise your hands and shout, "Hallelujah!"

In Galatians 6, Paul identifies two kinds of burdens that God calls us to carry: burdens we help others carry (v. 2) and burdens we must carry ourselves (v. 5). For decades others have helped us carry our burden of operating as a state convention. I am grateful for their faithfulness in helping us reach the lost of the Dakotas. Beginning on January 1, 2022, however, under the lordship of Jesus Christ and through His provision from the churches of North and South Dakota, this is a burden that we will now fully assume.

It is crucial to note, this does not mean we are striking out on our own totally apart from our SBC brothers and sisters. To the contrary, while we continue on the path to become a state convention that is "decreasingly dependent and increasingly independent," we will "always reflect cooperation." In fact, the ministry plan that was approved by the Executive Board and the budget that you will adopt create a strong framework for partnerships that are based on the mission, vision, and strategy that God has given us.

NAMB will continue to be a valued partner in the areas of church planting and evangelism. In the past year, NAMB has strengthened their commitment and investment in the mission that God has called us to accomplish. With their partnership, we have many church planters at work across the Dakotas, several more going through the pipeline to begin serving in the Dakotas, and resources to help evangelize the lost throughout the Dakotas.

Dakotas church planting team to work with and among us. When 2021 began, aside from planters, there were two NAMB-funded missionaries to help facilitate church planting in the Dakotas. As 2021 draws to a close and 2022 dawns, this team has doubled. Buck Hill will continue to serve as our State Director of Missions. Stephen Carson, T. J. Green, and Steve Ford will be church-based Church Planting Catalysts in various parts of the Dakotas. I look forward to working with this team to reach the Dakotas for Christ.

The difference that this budget and our new ministry plan make is that our partnerships will now be based solely on our strategy to reach the Dakotas. As we develop specific strategies that flow from our values, mission, vision, and objectives, we will have a foundation on which to build effective partnerships with others who have a burden to help us reach our Jerusalem.

On behalf of all Dakota Baptists, I want to say thank you to NAMB, Lifeway, fellow state conventions, and other SBC partners who have supported and strengthened us over the years. We are forever grateful for the grace you have shown. And we renew our commitment to partner with you in the cause of the gospel of Jesus Christ.

#### A reNEWed commitment and invitation

The Cooperative Program has always been "the financial fuel for reaching every person for Jesus Christ in every town, every city, every state, and every nation."\* Both the Cooperative Program and our Baker State Mission Offering will have a growing importance as we continue to stand on our own as a state convention.

The Cooperative Program is one practical way that we carry the two burdens God has given us to carry. Through CP dollars we help carry burdens for others around the world through missionaries and planters here in North America and on the international mission field, through the work of our six Southern Baptist seminaries, and through other vital areas of Kingdom work. In our budget, 25% of the CP dollars given by your church is forwarded to join with the CP giving of other SBC churches to do Kingdom work here in the U.S. and around the world. And, if we reach our 2022 CP target of \$428,400, 50% of everything above that amount will go to worldwide Cooperative Program work.

Equally important, through CP dollars we carry the burden that we must carry ourselves to reach every Dakotan with the gospel of Jesus Christ. In our budget, the other 75% of the CP dollars given by your church does Kingdom work here in North and South Dakota.

To reach the 2025 goals that were set last year regarding our staff structure and the new ministry plan and budget from this year, we must make a renewed <u>commitment</u> to both the Cooperative Program and our state mission offering. I anticipate that by 2025, we will be looking at CP giving goals in the range of \$500,000 and a state mission offering goal of \$50,000.

This may sound like a huge task, but we serve a God who, "is able to do exceedingly abundantly beyond all that we ask or think, according to the power that works within us" (Eph. 3:20). And, we have a strong fellowship and unity as Dakota Baptists. In Christ, we can do it.

To help communicate the importance and the work of both the Cooperative Program and our state mission offering to the work of Christ in the Dakotas and beyond, I would like to extend to each Dakota Baptist church an <u>invitation</u> to designate a "CP Ambassador."

A CP Ambassador is someone who is: 1) committed to see the Great Commission fulfilled in their community, across the Dakotas, and around the world; 2) enthusiastic about the Cooperative Program and the Dakotas state mission offering as tools to share the gospel; and 3) prayer-focused and mission-minded.

Through Zoom meetings and other opportunities, we will train CP Ambassadors and provide resources to enable them to be a champion in their church for Dakota-wide and worldwide cooperative mission work. I will share more about CP Ambassadors at the annual meeting.

#### And, in conclusion . . .

God is at work in, through, and around the Dakotas. Thank you for your faithful partnership in taking the name of Jesus to every corner of North and South Dakota and to the "remotest parts of the earth" (Acts 1:8). And thank you for the love that you have shown to Denise and me in our return home to the Dakotas. It is my greatest blessing to serve Christ with each of you. I will see you in Mandan.

# Sean Donnelly Church Relations Missionary Annual Report

Greetings to the Messengers of the Annual Gathering -

Thank you again for your support in this work of Church Relations Missionary. Truly our theme is true, that we are willing and working together for Him. I would like to take a moment and provide an account of some of my activities over the last few months.

Through church connections and support, we have been able to provide on-going interim support for two churches in our area as well as provide references for pulpit supply. These efforts have helped sustain one church through a difficult time of transition and given them the time to develop a pastor search committee and plan for their next steps. We are also in the process of connecting with a church who is losing their pastor and providing support for the search committee.

This role has also served as a connection point between the DBC and the Black Hills Area Baptist Association, such that we have been able to facilitate partnership on several funding requests. This kind of cooperation is vital and leads to healthier churches and associations.

One of my greatest joys in this work is being able to celebrate with churches as they meet milestones and achieve great things. We have had churches complete major building projects like new sanctuaries, full church remodels, and large additions. One of our area churches in Pine Ridge even became a SEND Relief site! However, we do have some sad reports of pastors leaving the area and two churches deciding if they can keep their doors open. Would you pray for the pastors who are experiencing discouragement as well as those who are enjoying times of victory and growth?

I have been able to lead a peer-group coaching luncheon with a handful of pastors from the Black Hills area. This is a great group, and we follow the Blackaby Spiritual Leadership Coaching model.

In the Badlands Association, I attended their Spring associational meeting and had the opportunity to get to know their Associational Missionary, Larry Vickery, as well as meet most of their pastors. We had a wonderful time of fellowship after the meeting and a connection was made between a pastor with a Jewish background and a Jewish outreach ministry in the Black Hills. Half the churches of Badlands were able to host a VBS this year and it was their joy to serve the children of their communities.

Finally, it has been my pleasure to be able to reach out to churches about the Baker Mission offering, not just to invite into participation this year, but to remind about ministry funding opportunities still available through previous offerings.

Please be in prayer for the continued ministry to the churches and their willingness to cooperate together for the advancement of the gospel.

I first want to extend my thanks for allowing me the opportunity to serve our Dakota Baptist Churches in the Heartland and Siouxland Associations as well as those churches East River who are not affiliated with an association. This year has been exciting in learning new ways to serve and in generating a new way of interacting with colleagues that I probably wouldn't have interacted with otherwise.

We have had some exciting things happening around the area including Chip Holmes producing videos for social media called Discipleship 101 that has had a reach as far as Kenya. Ben Farrar has been producing his own videos for social media presenting Christian Doctrines for comparison with Native American Spiritual traditions. I recently had the opportunity to share that these are available on YouTube with a Mennonite pastor in Mobridge who has been trying to figure out how to confront some claims about the two belief systems. Jane Hinrichs held "July Jesus Talks" with school age girls in Dupree where they talked about Jesus, worked on craft projects, and learned how to pray.

Sovereign Grace in Aberdeen is working on renovating the old Aberdeen Newspaper facility. Grace Community Church in Watertown is experiencing growing pains and is needing to locate a larger facility to handle their growth.

Restore church in Yankton is wrapping up the construction of their children's area, and it looks awesome. They are also holding services at their new plant in Crofton, Nebraska. Set Free church in Beresford has been doing weekly food distributions to provide food to the community. They've had other groups come to get food to provide for other communities in the area. Connection Church of Sioux Falls is working toward a plurality of elders model of church polity. Cornerstone Baptist is set to hold a deacon ordination on 9/25.

My statewide project is the Ministry Safe program. In June, I was able to present a portion of the material in person to the camp volunteers. We will be sending out information to next year's camp volunteers so that they may complete to program online. I spent eight years employed in the field of Safety and Security and have completed a Master of Corporate Security Leadership. It is my desire to see churches across the Dakotas take seriously the responsibility of having a safe environment for everyone who steps through the doors. My experience and knowledge is available to anyone who has any questions in that area of ministry.

## Dakota Baptist Convention Articles of Incorporation and Constitution

Approved September 21, 2017

#### ARTICLE I - NAME

The name of this Corporation is and shall be the "Dakota Baptist Convention, Inc." (Convention).

#### ARTICLE II - DURATION

The term of this Corporation shall be perpetual, unless sooner dissolved.

#### ARTICLE III - PURPOSE

**SECTION 1.** The purpose of this Corporation (Convention) shall be to furnish a medium of cooperation for member churches in North and South Dakota in their divinely commissioned work of missions, evangelism, education, and benevolence in keeping with the strategy adopted by the Executive Board. This Convention is an autonomous body made up of messengers from cooperating Baptist churches in Annual Session. This Convention shall not exercise authority over any church but shall always recognize and hold inviolable the autonomy of each local church under the Lordship of Christ.

**SECTION 2.** The enumerated purposes and powers of the Convention shall not proscribe or abridge the exercise of any other right or power which the Convention might now or hereafter be permitted or required to exercise by law, provided always that such powers shall be exercised for the benefit of member churches of the Convention consistent with the purpose and mission of the Convention.

**SECTION 3**. This Convention is a non-profit Corporation, organized and operating exclusively for religious purposes. As such, no part of the revenues of this Convention may inure to the benefit of any individual. The assets of the Corporation are exclusively and irrevocably dedicated to and for religious purposes. As such, no assets of the Convention may be used for or inure to the benefit of any individual.

#### ARTICLE IV - MEMBERSHIP

**SECTION 1.** The membership of this Convention shall consist of messengers to the Annual Meeting or a called meeting of the Convention, duly elected by legally constituted cooperating (member) churches.

- 1(a) A local church affiliates with the Dakota Baptist Convention (1) by affirming the current Baptist Faith and Message by vote of the church and written notification to the Dakota Baptist Convention, (2) by contributing to the Dakota Baptist Convention Cooperative Program a minimum of \$500.00 per calendar year, and (3) by submitting an Annual Report (the Annual Church Profile, ACP) to the Convention.
- **1(b)** Churches wishing to affiliate shall be put on probationary status upon affirmation of the current *Baptist Faith and Message*. Churches shall be eligible for full membership in the Convention after meeting the requirement for Cooperative Program giving and submission of an Annual Report (ACP) to the Convention. Probationary status for a church or church plant is

removed when the church has met all requirements and is approved by the Executive Board of the Convention.

SECTION 2. Each cooperating (member) church electing messengers to the Convention in session is allowed three (3) messengers. Churches are allowed an additional messenger for each additional fifty (50) resident members or fraction thereof over the first fifty (50). A church may add an additional messenger for each \$500 in Cooperative Program contributions to the Convention during the report period of the Annual Report. However, no church may seat more than ten (10) messengers to the Convention in session. Any church plant, church-type mission, or church that is either (1) not legally constituted or is (2) in probationary status shall be entitled to one (1) messenger to the Convention in session.

SECTION 3. The basis for determining resident membership and Cooperative Program contributions shall be the Annual Report (ACP) submitted to the Convention in the same calendar year as the Convention in session. If the Convention in session occurs so that there is inadequate time to review that year's Annual Report, the previous year's Annual Report may be used at the discretion of the Credentials Committee.

SECTION 4. Churches wishing to seat messengers at the Convention in session must show that they have contributed at least \$500.00 to the Dakota Baptist Convention Cooperative Program within the previous twelve (12) months, have submitted an ACP for the previous year, and have submitted the names of elected messengers to the Credentials Committee of the Convention before the opening of the Convention in session. Churches which do not meet the criteria for seating messengers may appeal to the Credentials Committee. Any such appeal must be submitted to the Credentials Committee Chairman before the opening day of the Convention in session. The Credentials Committee will evaluate the request to seat messengers on a case-by-case basis, guided by the current Baptist Faith and Message and information provided by the church, even if no Annual Report (ACP) is submitted for that calendar year. The Credentials Committee may recommend seating messengers from a church they consider to be genuinely in sympathy with the work and purposes of the Convention.

## ARTICLE V - NONPROFIT CORPORATION

The Dakota Baptist Convention is a non-profit Corporation organized under the laws of South Dakota. As such, the Corporation shall not have capital stock, and no dividends or pecuniary benefits shall be declared or paid to any member thereof. The Corporation shall neither have nor exercise any power, nor engage directly or indirectly in any activity that would invalidate its status as a non-profit Corporation under South Dakota law, or as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue code of 1986, as amended, or the corresponding provision or provisions of any subsequent United States Internal Revenue law or laws.

## ARTICLE VI - CORPORATE OFFICE AND AGENT

The address of the Convention's Registered Office is P. O. Box 549, 1604 Mountain View Road, Suite 1, Rapid City, South Dakota 57709. The Registered Agent at such address is the Executive Director-Treasurer of the Dakota Baptist Convention, Garvon Golden, or his successor.

#### ARTICLE VII - OFFICERS

- **SECTION 1.** The officers of the Convention shall be a President, Vice President, Recording Secretary, Assistant Recording Secretary, and such other officers as the Convention may determine.
- **SECTION 2.** The officers of the Convention shall be elected annually by a majority vote of the messengers present and voting at the Annual Meeting of the Convention. Elected officers shall take office at the close of the Annual Meeting and hold office until their successors are elected and installed.
- **SECTION 3.** The Executive Director-Treasurer shall serve as the Chief Executive Officer and Treasurer of the Convention and serve as an *ex-officio* member with vote of all Convention and Executive Board committees. Other employees of the Convention, its boards, or agencies shall not be eligible for election to any office.

#### ARTICLE VIII - EXECUTIVE BOARD

The Convention shall elect an Executive Board in keeping with provisions of the Bylaws of the Convention (Art. VII). The Executive Board shall serve as the Convention *ad interim* and as principal advisory body to the Convention.

#### ARTICLE IX - AGENCIES

- **SECTION 1.** The Convention may establish agencies to accomplish its mission. All agency board members shall be members of cooperating Dakota Baptist Convention churches.
- SECTION 2. The Convention in Annual Session shall approve or amend the articles of incorporation of an agency by two-thirds vote, provided that no amendment may be considered after the second session of the Annual Meeting. Any proposed articles or amendments must be submitted in writing to the Convention office at least one hundred twenty (120) days prior to the Annual Meeting, and notice must be published in the state Baptist paper or mailed to the churches at least ninety (90) days prior to the Annual Meeting.
- SECTION 3. Members of an agency's board of directors shall be elected by the Convention for three-year terms, with one-third of the directors elected each year. Directors shall be nominated by the Nominations Committee in consultation with that agency's then current board of directors. The Nominations Committee's recommendations shall be forwarded to the Convention office one hundred twenty (120) days prior to the Annual Meeting. The number of directors, their qualifications, and responsibilities, shall be stipulated in the agency's articles of incorporation and bylaws.
- **SECTION 4.** If a vacancy occurs on any agency board of directors, the Executive Board may elect a qualified person to serve until the next Annual Meeting, such person being recommended by the Nominations Committee. In no case may a vacancy continue for longer than six (6) months or until the next annual meeting, whichever occurs first. The Convention shall fill the unexpired term of a director at its next regular Annual Meeting.
- **SECTION 5.** An agency's board of directors in whole or in part may be replaced by a vote of the Convention in session or by a two-thirds vote of the Executive Board acting *ad interim*. Grounds for

replacement include misfeasance, incapacity, failure to perform assigned duties, or any conduct which would bring discredit upon the agency or the Convention.

**SECTION 6.** The Convention shall exercise oversight of all agencies through the respective boards of directors. Management responsibility for each agency shall be assumed by its own board of directors (trustees). The board of directors of each agency shall hold title to properties, real and personal, ensure fiscal integrity of the agency, employ agency personnel, make contracts on behalf of the agency, and conduct long range planning to achieve the objectives and accomplish the mission of the agency.

**SECTION 7.** Each agency shall report to the Convention in the Annual Meeting. This report shall include financial reports, projected budgets, progress on program objectives in light of long-range plans, and other information as requested by the Convention or its Executive Director.

#### ARTICLE X - COMMITTEES

The committees of the Convention shall be a Constitution Committee, Credentials Committee, Resolutions Committee, Nominations Committee, Program Committee, and such other committees as may be deemed necessary to carry out the work of the Convention. Members of committees shall be elected by the Convention and must be members of cooperating Convention churches. The assignment of each committee shall be established in the Articles of Incorporation and Constitution, and the Bylaws of the Convention.

#### ARTICLE XI - MEETINGS

- **SECTION 1.** The Convention shall meet once each year for an Annual Meeting. The time and place for the Annual Meeting shall be approved by the Convention, upon recommendation of the Program Committee.
- **SECTION 2.** In an emergency, the President of the Convention, in consultation with the Executive Board, may change the time and/or place of the Annual Meeting.
- SECTION 3. In an emergency, the President of the Convention, in consultation with the Executive Board, may call a special meeting of the Convention. See Bylaws, II.4

## ARTICLE XII - CONTRIBUTIONS AND FUNDS

- **SECTION 1.** The Cooperative Program shall be the chief means of financial support for all Convention programs and missionary endeavors.
- **SECTION 2.** All funds of this Convention shall be raised by voluntary contributions. However, the Convention may acquire property by bequest, or make use of any bequest, including use of any income producing assets.
- **SECTION 3.** All designated gifts accepted by this Convention shall be used strictly according to the expressed will and direction of the donor.
- **SECTION 4.** Neither this Convention, nor any institution or agency owned or supported in whole or in part by this Convention, shall accept or receive any funds, gifts, grants, or other monies or assets

from any government source (Federal or state) without the written approval of the agency's board. Any such funds received must be reported in full to the Convention's Executive Board.

#### ARTICLE XIII - INDEMNIFICATION

The Dakota Baptist Convention, and its agencies, institutions, and boards, shall indemnify any director (trustee) or officer, or former director or officer of the Corporation, and their respective heirs, administrators, successors, and assigns, against any and all expenses, including amounts paid upon judgments, counsel fees, and amounts paid in settlement (before or after suit is commenced), actually and reasonably incurred by such persons in connection with the defense or settlement of any claim, action, suit or proceeding in which they, or any of them, are made parties, or a party, or which may be asserted against them or any of them, by reason of having been trustees or officers or a trustee or officer of the Corporation; provided, however, that such indemnity should not be operative with respect to (1) any matter as to which such person shall have been adjudged in such action, suit, or proceeding to be liable for negligence or misconduct in the performance of his duties as such trustee, officer, or employee, or (2) any matter settled or compromised, unless, in the opinion of independent counsel selected by or in a manner determined by the trustees, there is not reasonable ground for such person's being adjudged liable for negligence or misconduct in the performance of his duties as such trustees or officer.

#### ARTICLE XIV - AMENDMENTS

Amendments may be made to this Constitution/Articles by a two-thirds vote of the members (messengers) present and voting at any Annual Meeting of the Convention, provided that (1) no amendment may be considered after the second session of the Convention and that (2) the proposed change is submitted in writing to the Convention office and the Executive Board at least one hundred twenty (120) days prior to the Annual Session and published in the state Baptist paper or mailed to the churches at least ninety (90) days prior to the Annual Session.

#### ARTICLE XV - DISSOLUTION

Section 1. In the event of the dissolution of the Corporation (Convention), all of its property, whether real, personal, or fixed, of whatsoever nature and wheresoever situated, shall be vested in the cooperating churches or their legal successors. The Corporation shall have authority through the Executive Board to liquidate any and all assets in such manner as they deem advisable and advantageous and to donate any proceeds to the North American Mission Board of the Southern Baptist Convention for work in the Dakotas.

**Section 2.** Assets held by the Corporation that are subject to conditions requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements.

**Section 3.** Under no condition or circumstances shall any member or members, director or directors, officer or officers, or any other persons connected with this Corporation share in the proceeds of such liquidation.

#### ARTICLE XVI - PROPERTY

The terms and conditions under which conveyances or encumbrances of all or any part of the corporate property may be made shall be authorized in keeping with the provisions of the Articles of Incorporation and Constitution and the Bylaws of the Convention.

#### ARTICLE XVII - INDEBTEDNESS

- Section 1. All borrowing by this Convention for its own use, or for any agency or institution, or borrowing by any institution or agency, which directly or indirectly obligates this Convention, the payment of which would require an extension of time beyond the close of the subsequent fiscal year, shall be authorized only on the following terms and conditions:
  - 1(a) The Executive Board shall have authority to borrow funds in anticipation of current revenue, provided that any unpaid balance of such borrowing at the end of the current fiscal year shall be included in the budget for the subsequent fiscal year.
  - **1(b)** No institution or agency of this Convention shall encumber its real property or change its status with respect to this Convention without authority from this Convention.
  - 1(c) Institutions and agencies of this Convention shall have authority to borrow money in anticipation of current revenue, provided that any unpaid balance of such borrowing at the end of the current fiscal year shall be included in the budget for the subsequent fiscal year.

Section 2. Any anticipated borrowing of funds other than those stipulated in the foregoing sub-section must be approved by a two-thirds vote of the Convention in session, upon recommendation of the Executive Board.

#### ARTICLE XVIII - AUTHORITY AND SUPERSESSION

These Articles of Incorporation and Constitution fully set forth the provisions of the Articles of Incorporation of the Dakota Baptist Convention as amended. They have been adopted as required by law, and they supersede the original Articles of Incorporation and all amendments.

## Dakota Baptist Convention Bylaws

Adopted September 21, 2017

#### ARTICLE I - MESSENGERS

- **SECTION 1.** Each member church shall present to the Credentials Committee of the Dakota Baptist Convention a list of its elected messengers, in keeping with the Articles of Incorporation and Constitution, Article IV.
- **SECTION 2.** Each messenger shall register with the Credentials Committee prior to being seated as a messenger to the Dakota Baptist Convention.
- **SECTION 3.** The Credentials Committee shall review the credentials of registered messengers and make its report to the Dakota Baptist Convention in the first business session of the Annual Meeting.

#### **ARTICLE II - MEETINGS**

- **SECTION 1.** The Dakota Baptist Convention shall meet each year for the purpose of worship, inspiration, electing officers, receiving reports of officers, committees, and boards, and for conducting necessary business.
- **SECTION 2.** The latest edition of *Robert's Rules of Order, Newly Revised* shall be recognized as the standard authority on questions of parliamentary procedure for the Dakota Baptist Convention.
- **SECTION 3.** A quorum for any session of any meeting of the Dakota Baptist Convention shall be defined as the messengers present and voting in that session.
- **SECTION 4.** The Dakota Baptist Convention shall approve its order of business at the first session of the Annual Meeting.
- SECTION 5. Special sessions of the Dakota Baptist Convention may be scheduled as follows: (1) The President, in consultation with the Executive Board, may call the Dakota Baptist Convention into special session as necessary, (2) The Dakota Baptist Convention in session can call for a special session by a majority vote.
- **SECTION 6.** The minutes of the Annual Meeting shall be received by the Executive Board at its first meeting following the Annual Meeting.

#### ARTICLE III - OFFICERS

SECTION 1. The recording secretary and assistant recording secretary will be nominated to the Convention by the Nominating Committee. The officers of the Dakota Baptist Convention shall be President, Vice President, Recording Secretary and Assistant Recording Secretary. The office of Treasurer shall be filled by the Executive Director-Treasurer of the Dakota Baptist Convention for an indefinite term.

- SECTION 2. The President and Vice President shall be elected annually from messengers in attendance at the Annual Meeting. Officers shall be members of cooperating Dakota Baptist Convention churches. Nominations shall be from the floor. Election shall be by ballot except when there is a single nominee for an office, in which case the President shall instruct the Secretary to cast a unanimous ballot for the nominee. The Recording Secretary and Assistant Recording Secretary shall be nominated by the Nominations Committee and elected by messengers at the Annual Meeting. They shall be members of cooperating Baptist churches.
- SECTION 3. Employees of the Dakota Baptist Convention, its boards and agencies are not eligible to serve as elected officers of the Dakota Baptist Convention, with the exception of the Executive Director-Treasurer, who serves an indefinite term as Treasurer.
- SECTION 4. Officers shall serve for one (1) year and hold office until their successors are elected and installed; however, no officer may serve more than two (2) complete successive terms in the same office except the Recording Secretary and Assistant Recording Secretary. Terms of office shall commence at the adjournment of the Dakota Baptist Convention in session at the time of their election and terminate at the adjournment of the succeeding Annual Session of the Dakota Baptist Convention. In case of death, disability, or other cause preventing continued service by the President, the Vice President, then the Recording Secretary, shall succeed in order. The Executive Board shall have responsibility for declaring an office vacant.
- SECTION 5. The President shall preside over all meetings of the Dakota Baptist Convention and shall perform such other duties as specified by the Constitution/Articles of Incorporation and Bylaws of the Dakota Baptist Convention. The President shall be a voting *ex officio* member of all Dakota Baptist Convention committees and boards. The President is authorized to appoint the Vice President to serve as *ex officio* member with vote of any committee or board in his/her absence.
- SECTION 6. In the absence of the President or when requested by the President, the Vice President may preside over meetings of the Dakota Baptist Convention, and shall perform other duties as specified in the Constitution/Articles of Incorporation and Bylaws of the Dakota Baptist Convention, or as may be requested by the President. The Vice President shall serve as a voting *ex officio* member of the Executive Board of the Dakota Baptist Convention.
- SECTION 7. The Recording Secretary shall produce accurate and timely minutes of all sessions of the Dakota Baptist Convention. A summary of minutes shall be filed at the Convention office, published, and sent to all cooperating churches in the Convention together with such other information as the Dakota Baptist Convention or the Executive Board deems necessary and proper. The Assistant Recording Secretary will assist in these duties. The office of the Executive Director-Treasurer may provide assistance as needed.
- **SECTION 8.** The presiding officer of a Convention session may appoint a parliamentarian to assist if the presiding officer deems it necessary or helpful.

## ARTICLE IV - EXECUTIVE DIRECTOR-TREASURER

SECTION 1. The Dakota Baptist Convention shall employ an Executive Director-Treasurer as its Chief Executive Officer and Treasurer. The Executive Director-Treasurer shall provide administrative

oversight, strategic leadership, and spiritual leadership for the total program of the Dakota Baptist Convention.

- SECTION 2. When a vacancy occurs in the office of Executive Director-Treasurer, the Administrative/Personnel committee of the Executive Board of the Convention shall conduct a search and shall recommend a candidate for the position to the Executive Board. A two-thirds vote of the Executive Board is necessary to elect a candidate. With permission of the candidate, the Executive Board shall release biographical data to the churches of the Dakota Baptist Convention. The Executive Board may select an Interim Executive Director-Treasurer to serve until the Executive Board elects a successor.
- **SECTION 3.** The Administrative/Personnel Committee shall be responsible for maintaining an up to date job description for the position of Executive Director-Treasurer. The job description shall be approved by the Executive Board of the Convention and reviewed on an annual basis.
- **SECTION 4.** The Dakota Baptist Convention in session may terminate the Executive Director-Treasurer by majority vote. The Executive Board may terminate the Executive Director-Treasurer by two-thirds vote of the elected members.

#### ARTICLE V - COOPERATING CHURCH OR CHURCH TYPE MISSION

A cooperating church or church plant shall be defined as follows: (1) The church has affirmed the current *Baptist Faith and Message* by a vote of its body, and confirmed that vote in writing to the Convention; (2) A cooperating church contributes regularly (quarterly or monthly) to the Cooperative Program and contributes a total of at least \$500 each year; (3) A cooperating church reports yearly through an Annual Report (Annual Church Profile; ACP). Churches failing to contribute to the Cooperative Program for a twelve (12) month period, or failing to submit an Annual Church Profile, or failing to affirm the current *Baptist Faith and Message* will be deemed non-cooperating.

#### ARTICLE VI – DAKOTA BAPTIST CONVENTION COMMITTEES

#### SECTION 1. STANDING COMMITTEES

The President of the Dakota Baptist Convention shall nominate the Standing Committees, including their chairmen, for election by the Dakota Baptist Convention in session. Members of Standing Committees shall serve a two-year term. Each Committee will elect its own Secretary. The Committees will schedule meetings as needed but are encouraged to utilize time during or near the Annual Meeting of the Convention. Each Committee should review its work in consultation with the Dakota Baptist Convention President and Executive Director-Treasurer. The Standing Committees are as follows:

- 1(a) Constitution and Bylaws. The principle duty of the Committee is to review the Constitution and Articles of Incorporation and Bylaws of the Dakota Baptist Convention and the bylaws of its agencies, and to recommend changes as appropriate. The Committee shall present any recommendations to the President and Executive Director-Treasurer 120 days before the Annual Meeting and publish the recommendations in the state Baptist paper or mail to the churches 90 days before the Annual Meeting.
- **1(b)** Nominations Committee. The Committee is responsible for recommending members for the Executive Board of the Dakota Baptist Convention and members of the boards of directors

of the Convention agencies in keeping with Constitution/Articles of Incorporation and Bylaws of the Dakota Baptist Convention. A diversity of committee nominees is desired, e.g., in terms of gender, ethnicity, vocation, geography, churches, and associations. It is expected that each nominee will act in the best interests of the Dakota Baptist Convention work as a whole. The Nominations Committee shall submit a full report to the Executive Director-Treasurer of the Dakota Baptist Convention 90 days before the Annual Meeting, for inclusion in the annual *Book of Reports*.

#### SECTION 2. ANNUAL COMMITTEES

Annual Committees are the Annual Session/Program Committee, Credentials Committee and Resolutions Committee. The Credentials Committee and Resolutions Committee shall be appointed by the President of the Dakota Baptist Convention within thirty (30) days following the close of the Annual Meeting. The Annual Session/Program Committee shall consist of individuals determined by the positions they serve. Members of Annual Committees will serve a term of two (2) years.

- 2(a) Annual Session/Program Committee. The Program Committee shall consist of the President, Vice President, the Executive Director-Treasurer, staff of the Dakota Baptist Convention, and a representative of the host association. The Committee is primarily responsible for planning the program and future sites for the Annual Meeting. The Committee will also assist in enlisting program personnel, assist the President in amending the order of business during the Annual Meeting, and assist with other related matters as requested by the President or Executive Director-Treasurer of the Convention. The Committee is responsible for recommending a site for the Annual Meeting of the Convention, considering the need to rotate sites throughout the Dakotas, and the availability of adequate meeting space and adequate hotel/motel rooms. The Executive Board will recommend to the Committee times and dates for the Annual Meeting two to five years in advance.
- **2(b)** <u>Credentials Committee.</u> The Credentials Committee is responsible for certifying messengers from churches for meetings of the Dakota Baptist Convention. The Committee will provide messengers with badges, ballots, and other materials for the execution of their duties as messengers. The Committee will assist the President in all balloting processes, certify votes and elections, and assist in related matters as requested by the President or Executive Director-Treasurer of the Convention.
- **2(c)** Resolutions Committee. The Resolutions Committee shall review all properly submitted resolutions and shall present resolutions to the Convention for consideration. All proposed resolutions to the Dakota Baptist Convention are to be submitted in writing 30 days in advance of the Annual Meeting. The Committee may edit resolutions for clarity, combine like issues into one resolution, or reject resolutions deemed redundant, obsolete, or inappropriate. The Resolutions Committee shall ask for proposed resolutions to be submitted prior to 30 days before the Annual Meeting.

## ARTICLE VII - EXECUTIVE BOARD

SECTION 1. Organization. The Executive Board shall organize itself and elect its officers upon the adjournment of the Annual Meeting. The officers of the Board shall be elected by the Board and shall consist of a Chairman and Vice Chairman. The Chairman may serve as Chairman for no more than three

(3) years. The Recording Secretary and Assistant Recording Secretary shall serve as secretaries for the Executive Board but shall not be considered members of the Board.

SECTION 2. Number of Members and Terms. The Executive Board shall be composed of no more than twelve (12) elected members and three (3) ex-officio members with vote, viz., the Executive Director-Treasurer, President, and Vice President of the Convention. Upon the recommendation of the Executive Board, the Convention in Annual Session can increase the number of Board members as needed. Executive Board members shall be elected for three-year terms. After the first three-year term a member may be elected for a second three-year term. After serving a second three-year term the member must rotate off the Board for at least one (1) year before being eligible to serve again. When a person fills an unexpired term of a member, that person can serve the rest of that term and can be eligible to serve another three-year term as long as both do not exceed six (6) years.

SECTION 3. Administrative/Personnel Committee. The Executive Board shall establish an Administrative/Personnel Committee, which shall meet as necessary between sessions of the Executive Board. The Administrative/Personnel Committee shall perform duties as assigned to it by the Executive Board. The Administrative/Personnel Committee shall be composed of the Executive Board Chairman and Vice Chairman, one Executive Board member at-large, and the President, the Vice President, and Executive Director-Treasurer of the Convention. The specific duties of the Committee are to act between sessions of the Executive Board as assigned, monitor and recommend changes to policies of the Dakota Baptist Convention, help prepare the Board agenda, recommend the Executive Board organization and temporary work groups, supervise the Executive Director-Treasurer on behalf of the Board, serve as the search committee for an Executive Director-Treasurer when a vacancy occurs, consult with the Executive Director-Treasurer on recommendations for prospective staff personnel, and work with the Executive Director-Treasurer and Convention staff in developing and implementing long range strategic plans.

SECTION 4. Responsibilities. The Executive Board is to serve as the Dakota Baptist Convention ad interim and as the principal advisory body to the Convention. The Executive Board shall not contravene actions or policies of the Dakota Baptist Convention. Specific responsibilities of the Executive Board are as follows:

- **4(a)** Serve as the operating board for all Convention programs not assigned to other boards or agencies.
- **4(b)** Evaluate the performance of the Executive Director-Treasurer of the Dakota Baptist Convention, and assist him in the exercise of his responsibilities for program and spiritual leadership as Chief Executive Officer of the Convention.
- **4(c)** Act as agent of the Dakota Baptist Convention in all matters not assigned to Convention agencies, to include execution of any and all deeds, mortgages, deeds of trust, assignments, or other conveyances that the Executive Board may deem necessary to its legal and fiduciary responsibilities. The Dakota Baptist Convention herewith authorizes and directs the Chairman of the Executive Board and its Executive Director-Treasurer to execute all such aforementioned documents on behalf of the Dakota Baptist Convention.
- **4(d)** All gifts of money other than the general budget of the Dakota Baptist Convention or other property made to the corporation shall be disbursed according to the donor's designation. The

corporation shall have the power at all time to accept or reject designated gifts. Undesignated gifts shall be distributed in accordance with the corporation's budget.

- **4(e)** Act upon recommendations of the Nominations Committee to fill any vacancies occurring between Annual Meetings.
- **4(f)** Provide oversight of and ensure adequate arrangements for all Dakota Baptist Convention sessions.
- **4(g)** Recommend a proposed budget to the Convention for each fiscal year. The proposed budget shall be published and distributed to all the churches of the Dakota Baptist Convention at least thirty (30) days prior to consideration and vote by the Convention in its Annual Session.
- **4(h)** Establish and revise policies relating to the duties of the Executive Board and maintain policy manuals. The Executive Board shall work closely with the Executive Director-Treasurer to ensure an organization that is both functional and accountable. Policy manuals are subject to review and may be amended by a simple majority vote of the Executive Board.
- **4(i)** Provide oversight for long range planning of the Dakota Baptist Convention and coordinate the long-range planning of any agency board with the long-range plan of the Convention.
- **4(j)** Ensure a regularly scheduled audit (at least every two years) of the Dakota Baptist Convention's financial records, publish financial reports in the *Book of Reports* at each Annual Session, and oversee the management of all Convention accounts.
- **4(k)** Approve and employ Board approved staff personnel upon recommendation of the Executive Director-Treasurer and the Administrative/Personnel Committee. The Executive Board shall approve personnel policies.

### SECTION 5. Meetings.

- **5(a)** The Executive Board shall meet at least three (3) times each year on dates suggested by the Executive Director-Treasurer and approved by the Executive Board, and at additional times as determined by the Board. The organizational meeting of the Executive Board shall be held following the Annual Meeting.
- **5(b)** Members are expected to attend all Executive Board committee meetings and plenary sessions. Failure to do so may result in removal by the Dakota Baptist Convention in session. Each member is responsible for notifying the Chairman of the Executive Board or the Dakota Baptist Convention office in any case necessitating an absence.
- **5(c)** The Executive Board may be called into special session by the Administrative/Personnel Committee.
- **5(d)** A majority of the Executive Board shall be considered a quorum for any Board meeting.

#### SECTION 6. Reports.

- **6(a)** The Executive Board shall prepare and publish a comprehensive report of the work of the Dakota Baptist Convention and a summary of actions taken by the Executive Board in the annual Book of Reports.
- **6(b)** The Executive Board shall publish a summary of Executive Board actions in the state Baptist paper after each session.

#### ARTICLE VIII - AMENDMENTS

Amendments may be made to these Bylaws by a simple majority of the messengers present and voting at any Annual Meeting of the Convention, provided that (1) no amendment may be considered after the second session of the Convention and that (2) the proposed change is submitted in writing to the Convention office and the Constitution and Bylaws Committee at least one hundred twenty (120) days prior to the Annual Meeting and published in the state Baptist paper or mailed to the churches ninety (90) days prior to the Annual Meeting.
